SUMMARY

The subject "Regulation of Contract of transport" is a four-monthly optional course with a total teaching load of 6 credits, taught in the fourth year of the Degree course Administration and Business Management.

The course aims to provide an integrated vision of land, air and sea transport law. The subject deals with the study of the aspects related to the legal status of the transport business, the most common transport contracts, freight operators and passengers by land, sea or air, and multimodal as well as other contracts related to transport and, in particular, insurance contracts.

Other requirements

The study of the subject requires the student to know the statute of a commercial business and to have a basic knowledge of the general theory of obligations, contracts and commercial contracts (Commercial Law I).

TEACHING METHODOLOGY

EVALUATION

Evaluation will consist of:

- 1. An oral or written examination. The exam will be worth 60% of the final grade.
- 2. An evaluation of complementary and related activities. This part will represent 40% of the final mark. To pass the subject in the first assessment the student must pass both the continuous assessment part (applied, directed and complementary activities) and the final exam.

ADDENDUM COVID-19

This addendum will only be activated if the health situation requires so and with the prior agreement of the Governing Council

This addendum to the academic guide of the subject will be applicable in the event that a re-outbreak of the pandemic determines the temporary closure of the classrooms (with a general or particular nature of the affected group), and only while it lasts, if applicable. , the confinement situation.

1. Contents.

The contents initially collected in the Teaching Guide will be maintained.

2. Volume of work and temporary planning of teaching.

The methodology applied varies according to the teaching modality that the teacher has chosen from among those indicated in section 2. In each group one or more of the following methodologies will be used accordingly:

Maintenance of the weight of the different activities that add up to the hours of dedication in ECTS credits marked in the original teaching guide.

Maintaining the distribution of the grade between the exam and the continuous assessment: 60% of the grade corresponds to the final exam grade. According to the Teaching Guide and its annex, 40% of the grade is assigned to continuous assessment. The continuous evaluation activities carried out in the ordinary face-to-face period and in the online period are not recoverable.

The sessions can be continued on the same dates and times with the same duration if the teaching is carried out through videoconferences through the Blackboard Collaborate.

Non-presential teaching can be received through videos that are generally published through MMedia UV.

3. Teaching methodology.

At the teacher's choice:



Upload of materials to the virtual classroom in word and pdf.

BBC synchronous video conferencing

BBC Asynchronous Videoconferencing

Solution of the cases given by the teacher to facilitate self-correction by the student.

Delivery of two cases resolved by the student that will be evaluated by the teacher.

Tutorials through email and videoconference.

Proposal of activities by virtual classroom

Design of alternative continuous assessment activities to replace the complementary ones that were programmed in the annex to the teaching guide and that could not be held because they were in person.

4. Evaluation.

The criteria indicated in the Annex to the Teaching Guide are maintained:

The final exam may consist of:

- Theoretical-practical written test with legislation, which represents 60% of the final grade, but distributed in the virtual classroom with limited time.
- Oral exam by videoconference, which will be recorded.
- 5. Bibliography.

The bibliography recommended by online materials will be complemented. The teachers will post in the Virtual Classroom the study materials for the topics that have not been explained in person.
