DESCRIPTION OF CONTENTS

1. Historical framework of Manual Therapy: definition and fundamental concepts

To know the historical framework of manual therapy and how it has evolved along the history. To study the history of the osteopathy and chiropractic as well as its influence in the manual therapy. To study the different manipulative trends which have been appearing within the physiotherapy and also the contributions of various authors in their evolution.

2. Clinical reasoning and diagnosis in Manual Therapy

Clinical reasoning can be defined as the thinking and decision-making processes which underpin clinical practice. The clinical reasoning involves the application of relevant knowledge (information, procedures, concepts) and clinical skills to treat the patient individually.

3. Clinical assessment in Manual Therapy: clinical tests, clinical prediction rules, diagnostic classification diagrams.

This thematic unit is an introduction to the theoretical aspects that characterize the clinical examination in manual therapy. It emphasizes that the clinical evaluation is based on theoretical knowledge and updated clinical reasoning processes that enable us to carry out a clinical history and a physical exam. The clinical evaluation of the patient is divided into two parts: the clinical history or subjective screening and physical examination

4. Therapeutic approaches within Manual Therapy

The objective of this unit is to study the different diagnostic, assessment and therapeutic procedures on manual therapy the diverse tissues that can be asses and treat

TEACHING METHODOLOGY

The theory lectures will take place in the classroom with the exposure of the program, participatory activities and cases of study. In the practical program, the student will learn through the resolution of problems and exercises, group activities and cases of study, and they will be trained in skills and procedures used in manual therapy. The student will prepare a portfolio over the course of the subject and submit it before the deadline indicated by the lecturer.



The teaching program may be modified during the development of the course if the teacher under teacher quality criteria and assimilation of knowledge by the student, deems it appropriate.

EVALUATION

Theoretical Program (50% of the final mark)

1.Written test: a) multiple-choice exam with 30 questions (30 %). Score = [hits-(errors/number of choices-1)]*(maximum score/number of questions); (b) 3 short questions to development (20 %).

Practical Program (50% of the final mark)

- 1.Oral examination (30 %). Simulation of the techniques in the practices and cases of study.
- 2.Self-work (20 %). Presentation of the team work. This work is mandatory. The written tests will be penalized if the spelling is incorrect.

The final mark for the course will be average, only when the student will have obtained at least a 5 out of 10 in each of the blocks theoretical and practical. The portfolio, and the exposure will not be eliminatory.
