SUMMARY

As part of the environment, soil survey is fundamental to the knowledge of it. In this discipline is to impart knowledge on soil formation and evolution, classification and distribution in the landscape. Students will learn the factors that influence the formation of soil, both general and specific processes are developed and the final type of soil that is formed to then classify and learn the techniques for analyzing their spatial distribution.

Such knowledge could be translated to the recognition of genetic processes and soil types in laboratory and field. The student will apply the theoretical to actual cases of soil and interpret the physical, chemical and physicochemical soil. Be taught to handle these data to recognize the kinds of soil and study will be completed in developing mapping techniques for translating the results into maps of soils (basic properties and thematic).

TEACHING METHODOLOGY

For the teaching of the subject of Soil Science will be held classroom (theoretical and practical) and thematic seminars offered at the beginning of the course. This will be done in groups. Other activities such as tutoring or monitoring of the course work will be carried out individually or in groups smaller than the previous activities. There will be a joint mentoring at the end of the theoretical agenda. It provides the student with teaching material and selected bibliography in the Virtual Classroom materia.

EVALUATION

During the development of the subject, both theoretical and practical classes, there will be a: Continuous 1. Valoración each student, based on regular attendance at classes and classroom activities, participation and degree of involvement in the process of teaching and learning and skills and attitudes displayed during the development of activities. 2. Para cadascuna d'elles es segueix el desenvolupament i metodologia que es descriu a continuació:

1. Continguts



Teoria: Es mantenen els continguts inicials recollits a la guia docent

2. Volum de treball i planificació temporal de la docència

En la modalitat no presencial, es mantindrà la planificació temporal en la que s'impartirà la docència (teoria, laboratori, tutories) presencial.

La conversió del treball presencial a treball autònom i la conversió de les sessions de laboratori experimentals a altre tipus d'activitats formatives que cobreixen les qüestions clau, no afectarà al volum de treball total de l'assignatura.

3. Metodologia docent

Teoria: els continguts de les sessions de teoria es desenvoluparan en sessions no presencial mitjançant presentacions amb videoconferència, amb àudio i/o amb text complementari que es posarà a disposició dels alumnes a l'aula virtual. Les presentacions inclouran links a publicacions i vídeos de lliure accés que permet a l'estudiant ampliar els continguts de les presentacions, així com entendre els conceptes exposats.

Tutories: Proposta de qüestionaris online, exercicis o activitats per a la resolució pràctica, de les quals, una part es sol·licitarà la seua entrega a través de l'aula virtual.

Laboratori: Es proporcionarà un guió i/o vídeo amb les instruccions de realització d'una activitat equivalent junt amb dades experimentals, sense descartar sessions síncrones si fora necessari. Amb això, els estudiants elaboraran una memòria que entregaran mitjançant l'opció "tasca" de l'aula virtual, per a la seua posterior avaluació.

En tots els casos, els dubtes i qüestions sobre les presentacions es resoldran amb els mitjans disponibles a l'aula virtual, o a través del correu electrònic.

4. Avaluació

El pes de l'avaluació final es realitzarà de la següent manera:

1. Examen escrit final: 70%
2. Laboratori: 25%
3. Tutories 5%

La prova escrita consistirà en un examen únic de l'assignatura que podrà incloure qüestionaris i problemes a desenvolupar. Els qüestionaris es realitzaran via aula virtual. Els enunciats dels exàmens posaran a disposició dels alumnes en el dia i hora prevista per a l'examen. El temps de realització de l'examen serà proporcional a la seua extensió i dificultat. Abans de finalitzar el temps, els alumnes proporcionaran una copia escanejada de l'examen escrit mitjançant una tasca a través de l'aula virtual. Sols s'acceptaran arxius únics en format PDF. L'hora d'entrega serà la que atorgue el sistema. El



professorat es reserva el dret d'acceptar exàmens entregats fora de termini.

Si un estudiant desitja aparèixer com “no presentat”, tan sols deu ignorar la tasca d'avaluació final programada. Si durant la realització de la prova final, un alumne perd la connexió a l'aula virtual (sobrecàrrega, deficient qualitat, etc.) i no pugués pujar el seu examen, deurà enviar-lo, mitjançant correu electrònic, als professors encarregats en el termini establert.
