SUMMARY

The external practicals, carried out as a compulsory module during the last course of the degree, represent a first contact of students with the jobs world. The aims are to apply to professional activities the competences acquired during the degree, so that students may start to work in a particular working environment, which may facilitate their employability. The Faculty will take into account the previous information acquired for the student employability, what will eventually contribute to the appropriate adjustments for its optimization.

The external practicals could be carried out in any legal entity, either public or private, local, regional state administration, or in any centre devoted to formation or research, national or international, with which the Universitat de Valencia-Estudi General had a collaboration agreement on such kind of training activities.



PREVIOUS KNOWLEDGE

Relationship to other subjects of the same degree

There are no specified enrollment restrictions with other subjects of the curriculum.

Other requirements

In order to be allowed to follow this module, it is compulsory to have completed not less than 150 credits in the degree, so as being enrolled or having accomplished all the compulsory modules in the degree. In the case of external practicals that would be linked to a Trabajo Final de Grado (Final Work of the Degree), it will be necessary to be also enrolled in that module.

TEACHING METHODOLOGY

- 1. Previous documentation in relation to the activities to be carried out in the company
- 2. Compulsory attendance to the company to carry out the planned activities during the time periods scheduled.
- 3. Preparing a final report of the activities developed

EVALUATION

In accordance with the activities to be developed in the company, the Departments will be assigned the tutorship of the same. Likewise, it will be taken into account that the number of practices assigned by each Tutor is equitable.

The Tutor of the University will be responsible for explaining to the student the evaluation criteria of the practical memory, which will be established in a meeting with the student before the start of the practices. The Tutor of the University will evaluate the learning according to the rubric of evaluation of the external practices of the Center, where the following items are developed:

- 1. The written memory of the practices presented at the end of them. This report will have a value of 45% of the final grade, and will be evaluated:
- Formal structure and quality of the written report (13.5%).
- General contents of the memory (31.5%).
- 2. Participation of the student in the tutorials and completion of complementary activities, which will involve up to 5% of the final grade.
- 3. Qualification of the company tutor. The report of the External Tutor, through a questionnaire provided by the University, which will assess the skills acquired by the student, and which will represent up to 50% of the final grade. This assessment will take into account the attendance, the ability to integrate in the work group and the activity carried out by the student.
