SUMMARY

External practices are the way for students to apply academic knowledge acquired during the race and, in parallel, to acquire a practical knowledge of everyday life in the working reality. Therefore, it is a way to complete the academic training of university students within the real needs of the company.

TEACHING METHODOLOGY

The student will carry out the practices at the place of the professional in the field or the company in which the practices are carried out. An active methodology will be used that makes the student's involvement in their learning essential. To achieve this, a process of periodic tutorials will be followed, being able to be both individual and collective, which will be in charge of the academic tutor.

In addition, there are other options to guide and direct the proper development of practices, such as conducting a daily practice, seminars, etc.

EVALUATION

The evaluation consists of two parts (both have to be approved with a 5 or higher to be able to average between both marks):

a) Verification of the practice and completion of the final report of the tutor of the company / entity (evaluation questionnaire of external practices). Once completed by the company tutor, the evaluation will be sent to the academic tutor. This grade represents 50% of the total final grade.

b) Qualification of the FCAFE academic tutor, which accounts for 50% of the total final grade and is based on:

-the required 20-30 page practice report to be handed in by the student to the academic tutor on the established date (at the end of the internship) and in the format that each tutor recommends (depending on the characteristics of the practice), and in the interviews, tutoring and monitoring during the practice period.



-the academic tutor will reserve 10% of the grade for having participated in the FCAFE occupation and entrepreneurship forum that is held annually and organized by the FCAFE together with UV-occupation. In the event that this forum is not carried out and therefore has not made it possible for students to attend either in person or remotely, the aforementioned 10% of the grade will be part of the evaluation of the academic tutor.
