SUMMARY

This course has a propedeutic nature. It is intended to facilitate the incorporation of students to the University of Valencia and to the study of philosophy. Throughout the course the students will have the opportunity to become familiar with different aspects of this degree and with university life and will be informed about the resources, services and programs that our institution offers, as well as their rights and obligations.

A primary goal of this course is to get students to develop certain skills that are indispensable for the practice of a humanistic discipline and, in particular, for philosophical practice. For this reason, the course will be structured in two types of activities: a set of talks (which will include a guided tour to the Joan Reglà Humanities Library) and four workshops-seminars (which will occupy most of the course).



The seminars will focus on philosophical texts that students will discuss throughout the course and will have the following thematic orientation:

- Writing and discussing philosophical essays.
- Text commentaries.
- Citations and bibliographic references.
- Presentation and discussion of academic papers.

2. Workshop: Writing Philosophical Essays

The aim of this workshop-seminar is to familiarize students with the structure of different types of texts (in particular, essays) and to learn how to differentiate the goals of an essay (the defense of an original thesis) from the goal of a review or other academic texts. The seminar will focus on philosophical texts that we will read and discuss in class.

3. Workshop: Commentary of Philosophical Essays

The aim of the workshop is to learn to write a commentary on which the central argument of the commented text is reconstructed and assessed. We will work on the skills related to the identification of arguments in a text, the presentation of those arguments in writing, and of the students personal assessment of them.

4. Workshop: Citation and References

The aim of this workshop is to familiarize students with the most commonly used citation systems. We will focus on the ways to refer to words or ideas from other texts and how to record bibliographic references. The issue of plagiarism and its various types will also be addressed.

**5. Workshop: Presentation of Academic Works**

The aim of this workshop is to show what an academic work consist of, its component parts and the required rigour, both in its written and oral presentation. The most remarkable academic papers during the career of the student are taken as an exemple, including degree final project and masters degree final project. The workshop addresses, based on the discussion of a classical philosophical text, the approach and presentation of an academic work.

TEACHING METHODOLOGY

The task for the first weeks is to actively participate in a series of talks. In the following weeks, some seminars should be attended and some activities (exercises, essays, oral presentations,...) will be proposed to the students.

EVALUATION

1st call:

We will follow a continuous evaluation. 10% of the final grade will depend on attendance and participation in the first block of talks. The remaining 90% will depend on the marks obtained in the four seminars. Each seminar will have the same weight in the final grade.

In general, seminar grades will depend on an activity to be delivered approximately 7-14 days after the end of each seminar.
