SUMMARY

This course is structured in two parts: Political and Social Philosophy I and Political and Social Philosophy II. The course will allow students to obtain a frame of reference for the development of a wide set of general competences of the degree in Philosophy. The syllabus offers a set of philosophical reflections on human sociability, analyzes the nature of social and political phenomena, and presents the major political theories, making possible an in-depth knowledge of the most relevant theoretical perspectives on society, the state and democracy.

DESCRIPTION OF CONTENTS

1. Perspective and power

The subordination of culture to politics. Beyond the modern state. The last man and the limits of liberal democracy. The politics of aristocratic radicalism. Perspectivist criticism and genealogical hermeneutics. Nihilism and the good Europeans. Will of power, eternal return and overman. The transvaluation of values. Petty and great politics.

2. The disenchantment of the world

Understanding, interpretation and explanation. Charisma, legitimacy, power. Responsibility and conviction.



3. Political vitalisms

Politics of life. Community and association as ideal types. Sociability and interaction. Conflict and social distance. The individual and the freedom. Modernization theory. Tragedy of culture.

4. Reason, technique, dominion

Criticism of modernity. Metaphysics and violence. The essence of modern science. The world as representation.

5. The totalitarianism of reason

The eternal return and the conservative revolution. The concept of the political. Agonism and power. Decision and secularization. Liberalism and democracy. Exception status. Genealogy of the constituent power.

6. Enlightenment and barbarism

Noblesse oblige. Culture and politics. Considerations of an impolitical man. Republic and humanity. The new Enlightenment and the experimental character of politics. On fascism and tyranny. The final triumph of democracy. Athens and Auschwitz.

7. The politics of rebellion

The absurd and the power. Against nihilism. Plague in perspective. The power to create and the commitment of the artist. The thought of noon. The first and the last man.

8. Thought, judgment and responsibility

Memory, promise, forgiveness. Narrating and understanding. What is authority? Agonistic politics of responsibility. Radical democracy.

9. The archaeology of knowledge and the politics of truth

Criticism, truth and argumentation. The intellectuals and the power. Taking care of oneself as a practice of freedom. Aesthetics of existence and democratic parrhesia.

ADDENDUM COVID-19

This addendum will only be activated if the health situation requires so and with the prior agreement of the Governing Council

1.- Contents

The essential contents are maintained, in any case, since they are necessary to master the competences linked to this subject, although the length and emphasis can be adapted to the circumstances of each moment.

2.- Volume of work and temporary planning of teaching

The volume of work required to pass this subject is maintained, trying to adapt the procedures and activities to that end.

3.- Teaching methodology

In this subject teaching combines face-to-face with non-attendance, synchronous or asynchronous. The level of attendance will be adapted to the social and health conditions of each moment and to the specific conditions of the subject. It will be a hybrid model, so that the classes will be taught with the possible presence and the rest will be carried out in person. In any case, this hybrid model must necessarily be flexible in order to adapt to the circumstances.

In non-face-to-face teaching, synchronous modalities will be prioritized, which favor direct interaction with students.

4.- Evaluation

Continuous assessment activities will be promoted, which, on the other hand, can be combined with the requirement to pass specific activities, including a final global assessment. The details of the process will be specified in the classroom guide, taking into account the circumstances.
