**SUMMARY**

The course is basically an introduction to some of the fundamental ideas of the authors who created and developed what is now understood as the philosophy of language, in the period immediately after Frege and Russell. Such ideas and authors are considered an indispensable basis in the introduction to the philosophy of language of the analytic tradition. We will discuss the works by, among others, Kripke, Tarski, Davidson, Wittgenstein, Austin, Searle or Grice. The course will mainly address the following topics:- Theories of direct reference.- Links between the notions of meaning and truth.- Theories of meaning that focus on the use of signs in the framework of linguistic practices - The importance of acts and intentions in the interpretation of linguistic meaning.(Not all of the topics will have the same weight in the course. The professor in charge of the subject will determine which topics will be seen in more detail. Likewise, they will select within each topic (see 'description of contents' below) some of the specified subsections, not necessarily all).

- To accurately identify and formulate theoretical issues in this field and to follow their historical development.
- To compare and to critically assess different theories of meaning.
- To relate key concepts and issues of our field with concepts and issues of other philosophical areas –such as epistemology, logic, ontology, philosophy of mind or philosophy of science– and of other fields of knowledge –such as psychology or linguistics.
- To grasp the main thesis and argumentative structure of a philosophical text and to be able to write short papers where some standpoint is defended by advancing arguments.

**TEACHING METHODOLOGY**

Attending this course takes three hours a week, structured in the following way:

**LECTURES (two hours):**

- The content of the lectures will turn around a collection of texts selected from the bibliography. Our goal is to analyse and explain these texts from a critical point of view, and doing so in a way that fosters the student's acquisition of certain intellectual abilities and habits not based on the mere memorizing of lecture notes.

**SEMINARS (one hour):**

- During the seminars, the students will discuss together different issues related to the texts analysed in the lectures.
- The students will also be requested to make presentations of some of the most relevant texts selected from the bibliographical references.

**TUTORIALS.**

- Upon request, lecturers will hold brief tutorials in their office hours with students interested in discussing issues related to the topics of the lectures and seminars.



## EVALUATION

The evaluation in the first call will consist, either of an onsite written exam on all the contents covered (100% of final grade), or, if the teacher so states it, of exercises, presentations and other continuous assessment assignments (30% of final grade) and a final written test, possibly virtual (70% of final grade). The evaluation in the second call will consist of an onsite written exam on all the contents covered (100% of final grade). Evaluation misconduct and plagiarism will be considered in accordance with the ACGUV 108/2017 regulation.
