3. Unit 3. Principles of equity and values of equality between people. The equality as a right of citizenship and value of human diversity: ethnic group, gender and disabled people.

4. Unit 4. Inequality, discrimination and maltreatment: from maltreatment and discriminatory behaviour to the psycho-social welfare.

5. Unit 5. Equality, diversity and welfare. Principle of equality and egalitarian strategies. Equality plans. Application of the equality in different fields.



# 6. Unit 6. Subjectivity, identity and gender. Building subjectivity, diagrams and gender stereotypes. Multicomponency.

### **TEACHING METHODOLOGY**

Active and participatory methodology, integrating different methodologies in order to enhance the meaningful learning of the knowledge involved and the development of the competences of the subject.

M1. Theoretical classes given by the teachers in which the different contents of the subject will be developed, while promoting the students participation through the resolution of the questions that arise throughout the presentations.

M2. The face-to-face classes are of a theoretical-practical nature. They will be complemented with noncontact time, through the realization of activities proposed by the professors or seminars / workshops, with the aim of complementing the contents through group dynamics techniques, role-playing for the study of cases, learning based on problems, cooperative learning and other techniques that stimulate the teaching-learning process.

M3. Practical classes that will include both group dynamics and classroom presentations by the students about the assignments, as well as text comments.

M4. Conducting seminars, practical sessions, or workshops so that students can acquire the ability to develop and apply psychological knowledge to professional practice in an ethical manner and respecting deontological principles.

M5. Individualized tutorships in which students will be supervised so that they can adequately monitor the training activities. The Virtual Classroom forum may be used to facilitate clarifications from the teamwork's.



The use of mobile devices, tablets and laptops will be at the disposal of the teaching methodology proposed by each teacher.

### **EVALUATION**

The assessment will be carried out through:

- Assessment of theory and practical contents through objective questionnaire (final examination) during the scheduled final exam period. The examination will include questions about a selection of the contents and skills previously mentioned in the present course guide.

- Written or oral presentation of reports, individual or group projects, clinical cases, resolution of problems and handling of diagnostic tests.

- Active participation in classroom activities, seminars and workshops and motivation for quality in learning outcomes.

The continuous assessment will be 70% of the final grade, having to obtain a minimum of 3.5 out of 7 to pass this continuous assessment. This 70% will be divided into two parts: i 35% for classroom activities, where participation will be taken into account; ii) 35% for group work that will be presented in the classroom. In the second call, this part of continuous evaluation may be recoverable, and the professor will establish the delivery dates of the works. In this phase, the activities may be different from those carried out in the classroom during the course, taking into account the competences of this teaching guide.

The professor will specify the details of the works that the students will have to hand in during the course. These works will include practical activities, reports, oral presentations, attendance to the lecturer's office hours... etc., individually or in teams. Submission and presentation dates will be specified by the professor.

### GRADING SYSTEM.

The grading of the subject will be subject to the provisions of the Reglament d'Avaluació i Qualificació de la Universitat de València per a títols de Grau i Màster (ACGUV 108/2017 of May 30, 2017).

A minimum of 5 points in the final grade is required to obtain a pass.

According to UV regulations, the grade is specified in numerical expression from 0 to 10 with one decimal place, using the following grading scale:

- 0 to 4.9: fail.

- From 5 to 6.9: pass.
- From 7 to 8.9: outstanding.



- From 9 to 10: outstanding or outstanding with honors.

The best grades of each group will be taken into account to obtain the Honor Grades (as long as a minimum of 9 is reached). In case of a deadlock, an oral or written test will be held to break the difference. If not being able to award Honorable Mentions in a group, the Teaching Unit will agree on the assignment of the Honorable Mention to another group.
