**SUMMARY**

## DESCRIPTION OF CONTENTS

### 3. Gender and diegetization in mass culture

This paper analyzes the effects of the so-called "mass culture" on the construction of gender stereotypes. Addresses in particular the processes of objectification and alienation that generate some audiovisual products such as advertising discourse and the soap opera.

### 4. Language and gender difference

**6. The construction of the "other" "gender" in the gaze ethnographic technical**

## TEACHING METHODOLOGY
