SUMMARY

The subject *Fundamentals of Social Work* is the first approach of students to the discipline and profession of social work. Its competences are common to other subjects such as *Research, Diagnose and Evaluation in Social Work; Psychology; Sociology; Health and Social Work; Anthropology; Gender Equality and Non-discrimination; Law and Economics*.

This subject is the base for the acquisition of knowledge for the subjects *Methods, Models and Techniques of Social Work* and *Social and Communication Abilities in Social Work*.

Through this subject we will explore the world we live in and the role of Social Work in it together with other characters, situations and realities from our own and from external perspectives.

This experience will provide students with knowledge, skills and abilities needed to become good professionals through cooperative, reflective and continuous work throughout the course, where students will:



- Understand what Social Work is and what it means; how and why it began and its purpose.
- Learn about its values, ethical criteria and basic principles.
- Identify and incorporate knowledge about social problematic that affect so many people, groups and communities and about processes, values and social institutions at stake.
- Use texts and documents to illustrate objective and subjective aspects of reality which will help us widen our knowledge and discover that there is more to human life than what we consider as a reality, in order to reflect on our own representations, conditioning and possibilities of professional action.
