# SUMMARY

The core subject B2 (Social Policies and Social Work) account for 9 compulsory ECTS credits. Together with the core subject Social Services, it makes up module B (Institutional Context of Social Work), which includes 2 subjects (*Introduction to Social Politics* (2<sup>nd</sup> year, 2<sup>nd</sup> quarter) and *Social Politics* (3<sup>rd</sup> year, 1st quarter)), worth 4.5 ECTS credits each.

The subject *Social Politics* completes the information obtained in *Introduction to Social Politics*, based on the three areas included in Verifica.

The first main area is focused on a concept of *Social Politics* which provides sense and a global vision to specific interventions of social policies and the social services they belong to, as well as the professional interventions of the degree students. This aspect relates social policy to its origin in Philosophy of Law and its subsequent diversification into the use of social and economic rights and they guarantee in the open formulations of the social State we live in.

The second main area intends to present the contributions of Spanish thinking to the history of social policy in Spain through three elements:

1. The Institutions that have lead to social policies in Spain, differencing between historical periods such as the Restoration, the Spanish dictatorship, the 2<sup>nd</sup> Republic, Francoism and Spain under democracy.

2. Political actors and authors and their historical context; original thinking; their influence; their work; the institutions they worked in and their ideology.

3. Things done under the name "social politics" and those which have been omitted, explaining the reasons that justify these varied actions, the needs they met, the forms of provision, resistance to them, etc. This aspect is a summary of the history of the State of social welfare in Spain.

The third main area is the need of establishing a natural scenario for social politics in Spain: the European Union. The first thing is to present the European social model and later discuss whether the European Union is currently an added-value on the social policies of Spain and the member states.
