## TEACHING METHODOLOGY

### Theoretical classes

There will be four hours a week of theoretical face-to-face classes. Lecturers will explain the main contents of the subject in order to help the students understand the historical issues as well as the procedures of and the working methodology applied to historical research. To better assimilate the theoretical contents, practical sessions will be carried out. Lecturers will provide the students with the materials needed for these sessions.

### Continuous assessment

Students will have to complete a series of tests throughout the term in order to ensure their proper understanding of the main contents covered.

## EVALUATION

### 1. CONTINUOUS EVALUATION TESTS

Periodically, at the end of the topics related to the manuscript book (topics 2 and 3) and the printed book (topics 4 and 5), students will take an assessment test related to the contents taught. Both tests will be done in the classroom and the usual schedule of the subject.

The assessment tests will represent, as a whole, 30% of the final grade and the grades obtained will apply to the two calls of the academic year.

### 2. COMPLEMENTARY PRACTICES AND ACTIVITIES

The student will individually make a written comment or answer a questionnaire about the practice, depending on the nature of it. Complementary activities will be assessed with a written questionnaire. In total, the grade for the internships and complementary activities will mean 20% of the final grade. The qualification obtained will be maintained for the second call and in no case will it be recoverable.



### 3. EXAMINATION

The contents explained in the classroom will be the subject of the exam, which will correspond to the different points of the program. The exam will consist of a written test in which the accuracy and rigor in the treatment of the data, the coherence in the presentation of the contents and the ability to relate concepts will be especially valued. The written exam will take place on the official date set by the Center and will constitute 50% of the total mark. However, it should be noted that only those who obtain a minimum grade of 5 will average the other grades.

#### NOTE:

This evaluation system is based on the premise that teaching at the University of Valencia is, by definition, face-to-face teaching. Then, the student must keep in mind that attendance, both in the theoretical classes and those of a practical nature, is essential for a proper follow-up of the contents of the subject. Likewise, the student must be aware of the possibility of a part-time registration, when it is not possible to attend all the subjects that make up a full course (60 credits). However, the possibility will be established, in duly justified cases and only for those students who request it, to be evaluated without the need to attend all or part of the classes. In these cases, the student must proceed as follows:

- At the beginning of the course, it is necessary to communicate to the teacher responsible for the subject the incident for which he cannot attend class, which he must adequately justify in a documentary way.
- Having analyzed the situation, the responsible teacher will decide the possibility of evaluation without total or partial attendance to the classes of the subject.

Students who are in this situation must present, to be evaluated, all the work required by the teacher (not necessarily identical to those required during the course). In addition, they may be called upon to defend them orally before the teacher, as well as taking a test of acquired knowledge. The weight of the works in the final qualification will be 50% while the remaining 50% will correspond to the knowledge test.
