**3. Introduction to the history of historiography**

The birth of History in 19th century. Historicism and positivism, marxism and social sciences. The 20th century historiographical revolution: social history. Linguistic turn and cultural history. New historiographical currents.

TEACHING METHODOLOGY**A. Three hours per week of in-class (face-to-face class), distributed as follows:**

- 1) Theoretical classes given by university lecturers (30 hours/course). These classes will be for two hours per week, in which teachers expose the student the main aspects of the subject, systematizing its content and providing bibliography in order to prepare for the exam.
- 2) Experience-based classes (15 hours/course). To undertake practical exercises, which will take place within the scheduled in-classes. The aim is to assist the student with the reading, understanding, and analysis of texts and published articles provided in the reference bibliography.

B. To attend to workshops and complementary activities.

The students will do the 15 hours planned for the complementary activities or seminars as specified for each group

EVALUATION

Grades will be based on the following:

1st. Course work and attendance at complementary activities and seminars, as well as the exercises derived from them, as specified in **the ANNEX of each group**.

2nd. The final exam, which will assess both the exposure of the theoretical content acquired as its practical application. The exam questions will refer to the contents analyzed in the classes and the other activities of the course. To pass the course, a minimum score on the exam of 4 points on the 10 scale (or 2 on the scale of 5) is required. If this score is not achieved, the grades of the other works and activities will not be included in the final grade.



The exact percentage that each one of these aspects represents in the final note is the following:

1. Evaluation of practices, individual works and complementary activities or seminars.	50 %
2. Exam (necessary to exceed minimum fixed)	50 %
TOTAL	100 %

For the second call:

- 1) You have to take the exam and obtain the minimum score established for the first call (4 points on the scale of 10, or 2 on the scale of 5). The marks of the other works and activities of the course, will not be included in the final grade to anyone who does not exceed this minimum.
- 2) The note of the practices and the individual works of the first call is saved for the second. However, students can redo the work delivered during the course or do the omitted again.
- 3) Complementary activities that involve activity carried out during the course (visits, conferences, round tables, seminars, films...) are only included in the note of the second call when the student has attended and, where appropriate, has delivered the corresponding memories.

PRESENTIAL / SEMI-PRESENTIAL TEACHING

1. Contents

The contents initially included in the teaching guide are maintained

2. Workload and time schedule

The activities and their hours of dedication in ECTS credits marked in the original course guide will be kept. If the classrooms capacity according to the sanitary norms allows it, the theoretical class attendance will be 100% (if the capacity couldn't be guaranteed, the class attendance would be reduced). Supplementary activities (weekly hour P: total 15 h.) won't have class attendance and will be preferentially online. Teaching planning will be specified at the beginning of the term.

If the sanitary situation changes and no access to the University facilities is possible, all teaching activities will be carried out completely online. In this case, the adaptations will be communicated to the students through the Virtual classroom.

3. Teaching Methodology

Theory and practice classes that may be complemented with different types of materials and activities in the Virtual classroom.

Tutorials will be done online (through the UV corporate mail) or face-to-face by prior appointment with the teacher.

If the sanitary situation changes and no access to the University facilities is possible, teaching and tutorials will be carried out completely online. In this case, the adaptations will be communicated to the students through the Virtual classroom.

4. Evaluation

The evaluation criteria established in the Course Guide are kept.

If the University facilities were closed on the dates set in the official calendar for the final exam, the face-to-face exam will be replaced by an online test.

5. Bibliographic references

The recommended bibliography in the Course Guide is kept. If the sanitary situation changes and the access to the recommended bibliography is not possible, it will be replaced by materials accessible online.
