SUMMARY

The descriptor of the subject Rhetoric in the Degree in History and the Degree in Art History Curricula includes this subject in the basic training module in the first year of the Degree under the heading "Interdisciplinary Knowledge. Knowledge common to the Grades of History and Art History". This means that, in general, they are aimed at students who have just arrived at the University, something that must be considered in their design and planning. The specific descriptor of the above-mentioned curricula is as follows: "Learning the types, structure, phases, modalities and techniques of written and spoken expression; acquisition of oral and written expression skills for the performance of university activity".



With this approach, the subject has been conceived as a subject that combines theory and practice, aimed at developing the communicative skills that a university student needs to use in the field of Art History.

TEACHING METHODOLOGY

A methodology combining different organizational modalities is envisaged:

- Lectures and presentation of the contents of the course.



- Evaluable practices (individual or in a team).
- Activities of application and expansion of contents
- Tutorials to develop individualised attention to students.
- Individual or group work.

In the face-to-face classes, some sessions will be devoted to the theoretical explanation of the contents of the syllabus and the rest of the sessions will be devoted to the application of these theoretical contents to the practice of written and oral activities and practices.

COMPLEMENTARY ACTIVITIES:

Complementary activities may include:

- 1) Workshops to carry out work within the framework of oral and written communication.
- 2) The organization of debates with relevant guests in the academic or professional world, or from student presentations.
- 3) Attending conferences, exhibitions, etc.
- 4) Attending monographic sessions scheduled by the teaching staff.

EVALUATION

The evaluation blocks that will form the final grade can be defined between the following intervals:

- 1) Written proof of the contents of the syllabus (30% of the total)
- 2) Written academic work (15- 20% of the total)
- 3) Complementary practices and activities (20- 35% of the total)
- 4) Final oral talk in public (in class) (20- 30% of the total)

DELIVERY DATES AND EVALUATION CRITERIA

- 1) The minimum grade required for the grade of any part to be considered with the others and be part of the final grade must be 4 out of 10. If the note of any part does not reach 4, this note will not be incorporated into the global note and, in the case of a required part, the final grade will be “failing grade”.



- 2) Written test on the contents of the syllabus. It will take place on the date of the official examination established by the Faculty of Geography and History, in first and second call.
- 3) Written academic work. The deadline for the first call will be established by the teaching staff. The academic work will consist of a text of the typology determined by the teaching staff and must be submitted in printed and digital format.
- 4) With regard to complementary practices and activities (point 3), which is the 20-35 % range of the final grade, the teachers of each group will establish at the beginning of the course which ones will be required to pass the course, and which will be optional. In the case of optional complementary practices and activities, if the student does not do any, he/she will lose the percentage of the corresponding grade.
- 5) The dates of delivery of the internships will be established by the teaching staff of each group.
- 6) Submission of the written academic work specified in (2) and of the practices and activities specified in (3) after the established dates will result in a decrease in the grade.
- 7) The grade of the practices (3) and the final oral presentation (4) shall be maintained until the second call.
- 8) In case of no passing or not being presented in the written exam on the contents of the program (exam), the exam must be carried out on the date established by the Faculty for the second call; in case of failing or not being presented in the written academic work, it must be delivered on this same date. The same criterion will apply in those practices that the teachers of each group establish as mandatory, provided that these are recoverable in the second call.
- 9) Therefore, the second call corresponds to the exam (1), the written academic work (2) and written practices. The grades of the other evaluation blocks will correspond to the grade that each student has obtained in the first call.

Evaluation criteria

- 1) Written test on the contents of the syllabus. The suitability for the contents of the syllabus will be assessed, as well as the correctness and presentation, among other criteria.
- 2) Written academic work. Originality will be an exclusive criterion: the direct copy of texts from the Internet or other sources, except for the normative mechanisms of citation, will imply a substantial decrease in the grade and even the failure of the work. Gender appropriateness, writing skills, clear expression of content, style, grammar, spelling, presentation and layout, etc. will be assessed, among other aspects. At the discretion of the teaching staff, deficiencies in spelling correction or in presentation and layout may be grounds for failure.
- 3) The final oral presentation should be held in public in class during the period in which the subject is taught. Not performing the final oral exposure in the stipulated date without justified cause will imply a decrease of the grade if the student is assigned a new date, or obtain the grade "Not presented" in case it is no longer possible to assign a date within the classroom sessions of the student.



4) The teaching staff of each group will establish at the beginning of the course which tests are recoverable or non-recoverable.

PRESENTIAL / SEMI-PRESENTIAL TEACHING

1. Contents

The contents initially included in the teaching guide are maintained

2. Workload and time schedule

The activities and their hours of dedication in ECTS credits marked in the original course guide will be kept. If the classrooms capacity according to the sanitary norms allows it, the theoretical class attendance will be 100% (if the capacity couldn't be guaranteed, the class attendance would be reduced). Supplementary activities (weekly hour P: total 15 h.) won't have class attendance and will be preferentially online. Teaching planning will be specified at the beginning of the term.



If the sanitary situation changes and no access to the University facilities is possible, all teaching activities will be carried out completely online. In this case, the adaptations will be communicated to the students through the Virtual classroom.

3. Teaching Methodology

Theory and practice classes that may be complemented with different types of materials and activities in the Virtual classroom.

Tutorials will be done online (through the UV corporate mail) or face-to-face by prior appointment with the teacher.

If the sanitary situation changes and no access to the University facilities is possible, teaching and tutorials will be carried out completely online. In this case, the adaptations will be communicated to the students through the Virtual classroom.

4. Evaluation

The evaluation criteria established in the Course Guide are kept.

If the University facilities were closed on the dates set in the official calendar for the final exam, the face-to-face exam will be replaced by an online test.

5. Bibliographic references

The recommended bibliography in the Course Guide is kept. If the sanitary situation changes and the access to the recommended bibliography is not possible, it will be replaced by materials accessible online.

In addition, reference works that are part of the bibliography of the subject can be partially replaced by notes from sessions taught or by documents published in the Aula Virtual.
