TEACHING METHODOLOGY

A. Three hours per week of in-class (face-to-face class), distributed as follows:

- 1) Lectures given by teachers (30 hours / course).

These classes will last for three hours per week, in which teachers will expose the main aspects of the subject, systematizing contents and providing bibliographical references in order to prepare the exam.

- 2) Practical classes (15 hours / course).

The practical exercises will take place for 1 hour per week within the established classes.

The aim is to help students in the exercise of reading, analysis and understanding of texts and published works that are provided in the literature reference.

B. Attending seminars or complementary activities.



Within this compulsory student attendance at an event, organized by the teachers of the subject, including trips outside the classroom or conference attendance and / or case it included seminars. To be valued activity, you will have to submit a report on the activity. The characteristics and structure of memory the student prior to the implementation of the activity will be reported.

In addition to assistance to specific conferences or seminars, scheduled visits to a museum and a monumental complex with its own art collection. They serve the purpose of socializing students and teachers, some knowledge and and facilitate the exchange of views and experiences from direct contact with works of art, also assessing their condition and their conditions of visibility and appreciation from the public.

C. Unscheduled attendance to tutorials.

The student may attend the opening hours that the teacher has established to consult on any aspect or concerns related to the subject.

D. Attendance at scheduled tutorials.

The student may attend scheduled by teachers in order to expand theoretical and practical aspects of teaching hours outside the scheduled tutoring sessions.

EVALUATION

Evaluation will be based on the following items:

Tracking the preparation of lectures and practical classes.

1. This control takes place through the exercises and texts comments made in the practical sessions, in which the student participation will be assessed in the debate set established and written exercises to be delivered to teachers (individual or in a group work).
2. Attending seminars or complementary activities, of which you will have to submit a report or take an exam for final assessment. This will be complemented with the recommended control for the preparation of the actual classes readings.
3. It is final, in which both exposure value of the acquired theoretical knowledge and practical application. The exact percentage representing each of these aspects in the final grade is as follows:

Written test: exam 60-50%

Readings and complementary activities 30-20%

Evaluation of individual works 20-10%

For the second call: the written test or exam will have the same characteristics to the first call.
