**Prehistoria Universal antigua** (PUa) y Prehistoria Universal reciente son asignaturas que forman parte de una materia general dedicada al conocimiento de la Humanidad Prehistórica; ambas están incluidas en el segundo curso del Grado de Historia de la Universitat de València.

PUa es una asignatura que plantea a los estudiantes un panorama general de la evolución socio-cultural de la Humanidad prehistórica, anterior al desarrollo y expansión de las economías de producción de agricultores y pastores. Con este objetivo, se aborda una presentación de las principales teorías sobre la formación y desarrollo de las sociedades humanas anteriores a la producción de alimentos, así como las bases documentales utilizadas por la Arqueología durante el estudio de las sociedades de cazadores-recolectores-pescadores prehistóricos.



Por cercanía histórica y geográfica se prestará mayor atención a las regiones del Viejo Mundo y en especial a África y Europa.

## EVALUATION

### On the first call:

**Theory** = It will be a continuous assessment, with a set of exercises. The marks for this block will be the average of all grades and it will compute 75% of the final grade..

**Practical works** = 15% of the final grade.

**Complementary activities** = 10% of the final grade.

Students will bring works and materials on schedule deadlines. Those who do not participate in these actions will not have this proportional part of the final grade. Attendance will be accounted for through practical exercises uploaded to the Virtual Classroom platform.

The **final grade** will be the proportional computation of the previous items, but a **minimum grade of 4 points out of 10** in each of the blocks (theoretical, practical and complementary) will be required to pass the course.

### On the second call:

Those who have not passed a part of the course may take a **second-chance exam for the theory (75%), the practices (15%) and/or the complementary activity (10%)**.



The **final grade** will be the proportional computation of the previous items, which **must reach 5 points out of 10 global average**.

If the University facilities are closed on the dates set in the official calendar for the final exam, the face-to-face exam will be replaced by an online test.

The domain of the general outline of the evolution of prehistoric societies, the capacity for relationship and synthesis, the conceptual precision, as well as the capacity for analysis and explanatory clarity will be especially valued. Plagiarism in any of the jobs requested will lead to the rating of that job with a 0. The grade “Merit with Distinction” can be awarded to students who have obtained a grade equal to or greater than 9.0. This grade may be awarded for every twenty students within a group.

The activities and their hours of dedication in ECTS credits marked in the original course guide will be kept. If the classrooms capacity according to the sanitary norms allows it, the theoretical and practical class attendance will be 100% (if the capacity couldn't be guaranteed, the class attendance would be reduced).
