SUMMARY

This subject is part of the course "Modern History of Spain" (12 credits), which in turn is integrated into the module "History of Spain" (48 credits), of the third year of the degree in History. Its contents are articulated and complemented thematically with those of the subject "Modern History of Spain I", taught in the first semester. The essential purpose is to offer students a general knowledge of the economy, social organization and cultural manifestations in Spain in modern times.

LEARNING OUTCOMES

This course pretends that students acquire a critical and updated knowledge of the integration process of the two main geographical areas existing in the European modern age. The acquisition of that information, as well as the process to achieve it, will be the tools in developing reading comprehension skills, critical thinking and reasoned exposition.

In the study of the subject matter, the intention is to familiarize the students in the multi-causal reasoning and comparative perspectives. In the learning process, they must handle various skills for collecting information own of historical methodology.

The main objectives pursued are:

a) Conceptual character:



- Familiarization of students with the conceptual content inherent to the matter.
 - Facilitate the understanding of the great historical processes that led to the creation of a European economic system increasingly integrated.
 - Implement a method that enhances the explanatory synthesis through the ability to select, prioritize and coordinate information.
- b) Instrumental character:
- Introduction to the heuristic and methodological procedures for the construction of historical knowledge applied to the issues raised in the subject.
- c) Competence character:
- Develop the skills of analysis, knowledge management and argument, both through the selection of materials and through discussion and presentation of the results achieved in the different activities throughout the year.
 - Encourage the capacity of self-criticism and self-improvement that enhances to the student's concern for the quality of the personal work.

TEACHING METHODOLOGY

FACE-TO-FACE CLASSES: The classes will combine the explanations of the theoretical contents of the program by the teacher with analysis and practical comments on various materials (texts, maps, documents, etc.). Whatever the activity carried out, the participation of the students.

PREPARATION OF THEORETICAL CLASSES: The professor will indicate the pertinent readings for the adequate preparation of the theoretical classes.

PREPARATION OF PRACTICAL WORKS: In your case, the teacher will indicate the guidelines for carrying out practical work in the annex corresponding to your group, in addition to doing it throughout the course in class or through the Virtual Classroom.



TUTORSHIP: The students will be able to consult with the teacher in the following hours of any qualification related to the development of the classes, the performance of individual or team treballs, the lectures fetes and the complementary activities.

COMPLEMENTARY ACTIVITIES: The complementary activities proposed by the teaching staff will be related to the contents of the subject. They will consist of attending conferences, seminars, film screenings or other activities. For its evaluation, attendance and a memory will be compulsory.

EVALUATION

The evaluation of the subject in the first call will follow the following procedure:

1) Exam to be carried out on the date established by the center. The level of knowledge of the students will be assessed in accordance with the objectives of the subject, as well as the correct written expression (terminology and presentation), and the capacity for relationship and reasoning.

The specific examination procedures will be established by each professor, as stated in the corresponding Annexes.

2) Reading control tests will be performed according to procedure and schedule temporary established by the different teachers in their Annexes.

3) Other work and exercises that can be carried out throughout the course will be verified also in accordance with what is established by the professors in their respective Annexes.

4) The teachers will establish the deadlines and procedures for evaluating the complementary activities in accordance with their nature (making reports, control of attendance, etc.), as established for each group of the subject in the Annex.

5) The percentage that each of the evaluation tests will represent in the final grade of the subject will be the following:

The second call for the evaluation will comply with the following specifications:

1) It will consist of a final exam on the date established by the center.

2) The test of this second call will include all the content of the program.

3) The grade obtained by the student in the tasks and reading tests and in the complementary activities will be maintained.

1. Contents

The contents initially included in the teaching guide are maintained.



2. Workload and time schedule

The activities and their hours of dedication in ECTS credits marked in the original course guide will be kept. In order to guarantee distance and safety measures, theoretical and practical classes will have an attendance of 50%, with the rotation by alternate weeks of the students divided into two subgroups alphabetically. Supplementary activities (weekly hour O: total 15 h.) won't have class attendance and will be preferentially online. Teaching planning will be specified at the beginning of the term.

3. Teaching Methodology

Theory classes with attendance of 50% with the rotation by alternate weeks of the students divided into two subgroups which, according to the teacher's planning and technical availability, may be followed on the other 50% by synchronous videoconference through the Blackboard Collaborate platform or may be complemented with different types of materials and activities through the Virtual classroom.

Tutorials will be done online (through the UV corporate mail) or face-to-face by prior appointment with the teacher.

If the sanitary situation changes and no access to the University facilities is possible, teaching and tutorials will be carried out completely online. In this case, the adaptations will be communicated to the students through the Virtual classroom.

4. Evaluation

The evaluation criteria established in the Course Guide are kept. The annex to the Teaching Guide for each group will detail the activities that make up the evaluation.

If the University facilities were closed on the dates set in the official calendar for the final exam, the face-to-face exam will be replaced by an online test.

5. Bibliographic references

The recommended bibliography in the Course Guide is kept. If the sanitary situation changes and the access to the recommended bibliography is not possible, it will be replaced by materials accessible online.
