The student will know the diachrony of the Latin writing from the first century B.C. until the diffusion of the printing press of mobile types, particularly in the territories that from 1137 will constitute the Crown of Aragon. The student will be able to identify and describe the main types of written testimonies produced and used throughout the period to be studied, as well as the graphic phenomena in which they are inscribed. The student will be able to describe and analyze the internal and external characteristics of the diplomatic documents produced within the temporal space coordinates corresponding to the program.

**TEACHING METHODOLOGY**

There will be four hours of class a week, ie activity in the ordinary classroom subject or group, along which teachers will present and explain those fundamental aspects that will guide the student in the study and understanding of the different topics. Also, given the practical component of the course will be carried out various activities (identification and reading graphic types, identification of the parties and clauses that make up the tenor of the diplomatic documents, description of the physical characteristics of different products written) from a dossier of materials it will be provided by teachers.

**RESOLUTION OF CASE STUDIES**

Throughout the semester they will be held within the regular schedule of the subject, two practical tests. Teachers made available to students necessary materials for the resolution of practical cases and the appropriate indications for their realization. The resolution of practical cases will be evaluated.

**EXAM PREPARATION**

For the preparation of different issues, with a view to completion of the review, it will be essential to present the theoretical contents explained in the classes, additional readings, readings particularly recommended for each of the issues and practical activities in Classroom.

**EVALUATION**

1. **EXAM:** Will be under review the contents explained in the classroom, which will correspond to the different parts of the program. The exam will consist of a written theoretical and practical, according to the content and development of the subject test. The written exam will take place on the official date fixed by the Centre and constitute 70% of the total mark. However, it should be noted that only half will do with the rest of qualifications examinations to obtain a minimum 5 note.
2. **RESOLUTION OF CASE STUDIES:** Throughout the semester two practical tests, which represent 30% of the total score will be performed. The grades obtained will apply to the two calls of the academic year. In no case will they be recoverable.



Excepting Erasmus students, grammar and spelling mistakes will score negatively on the qualification of all written tests and academic works. Their accumulation may lead to a failing grade in the course.
