SUMMARY

According to the Study Plan, the course Practices External takes place in the second semester of the fourth year, is mandatory and has allocated 18 ECTS credits, of which 14 correspond to classroom activities in central practices (350 hours), personal seminars and additional training activities in the academic center (12.5 hours), independent study non-attendance (30 hours) and writing of reports (57,5 hours). The / students who are enrolled in that course with this course have the possibility of entering the professional field and apply the knowledge acquired and complement their academic training, experimenting in practice the implementation thereof. The / the student is on the cusp of their graduate studies, at which, in the embodiment of the external practices together with the development of the Bachelor Thesis, learning from everything converges and represents the culmination of their ability to work as a student, being necessary to link the two subjects.

The overall objective of the internships is to enable students to different training times when, through work experience in an area of performance of Sociology, start exercising basic professional skills to use the tools and techniques appropriate to the field of practice, professional activities related to the theoretical contents acquired during previous courses and to develop and apply practical skills work, so all monitored and evaluated.

The specific objectives of the program of internships are:

Meet the professional field of sociology and its relationship to fields.



Provide and apply knowledge to professional practice of sociology and social sciences.

Exercised in the selection and use of processes, tools and techniques of sociology and face real problems and situations.

Develop ethical and appropriate for professional practice interrelationship attitudes.

Consolidating professional skills. Collaborate in the development and coordination of social intervention projects in multidisciplinary teams.

Understand, value and applied in the workplace and the fundamental equality of men and women rights.

The contents of external practices within their diversity in terms of concrete collaborating center, can be systematized as follows:

Knowledge and analysis of professional activity in the sector in which the practice is carried out by applying the techniques and research methods of sociology.

Knowledge and analysis of the organization where the practice is developed in terms of their activities, structure and functioning, by applying the techniques and research methods of sociology.

Recognition and analysis of actual and potential roles of professional sociology in that organization.

Participation in team work and their organizational dynamics Collaborating Centre.

Collaboration activities contributor and concrete participation in them by the / of the student center.

Preparation of proposals for analysis and action on all the marked files, which will be developed in the Final Year.

To achieve the above objectives, he / she will be assigned a student / tutor / academic and / tutor / a company or training center; Also, the University of Valencia account for this purpose the services of the University-Enterprise Foundation ADEIT helps manage external practices through its Department of Business Practices; and the Faculty of Ciències Socials, the corresponding Placement Committee is responsible for the promotion, organization and supervision in coordination with the Academic Committee of the Degree in Sociology.

The external practices are regulated by externes Practiques Reglament of the University of Valencia (ACGUV 131/2012 of the University of Valencia).

Fields of work and type of target organizations for internships for the students of the Degree in Sociology are:

- 1) Support the development of social action and social action research in non-profit organizations in the area of social action.
- 2) Support for sociological research in local authorities (municipalities, local development agencies, etc..).
- 3) Support for sociological research in research institutes.
- 4) Insertion in business execution functions: business consulting, market research and other companies.

5) Organizations, Unions and political parties.



6) Research projects, participation and social action in secondary schools.

PREVIOUS KNOWLEDGE

Relationship to other subjects of the same degree

There are no specified enrollment restrictions with other subjects of the curriculum.

Other requirements

The student must have passed 150 credits of the 180 in the first three courses, distributed as follows:

- 60 credits of core subjects.
- 54 credit module sociological theory, structure and social change.
- 36 credit module methods and techniques of social science research.

This ensures the disciplinary knowledge to be applied and confronted with the practice and the ability to systematize and develop own practice.
