EVALUATION

Traditional theoretical assessment

Represents the 60% of the final mark. It will be made by written test that will be about the content of the theoretical program and it will have as the main goal to assess the knowledge acquisition. The content of the test will be the same for each group. This exam will consist of 40 multiple-choice questions. Each right answer will have the value of 1 point, the non-answered 0 points and 3 wrong answers will subtract 1 point. This part has a value of the 60% of the exam mark.

Practical competencies assessment

Represents the 40% of the final mark. It consists of:

- Identification of psychopathological symptoms

The same day when the exam takes places, a practical exam will be made that will consist of:

Identification of psychopathological symptoms in a video of a real clinical case (20% of the mark)

Identification of psychopathology in a short piece of a film (10% of the mark) (the list of the candidate films will be given prior to the exam). The student must describe briefly the main symptoms appearing in the video and in the short piece of film.

- Continuous assessment of practical competencies: represents the 10% of the final mark. It will be made by the assessment of the participation in the following activities:

Seminar of Cognitive evaluation (5% of the mark)

Seminars of Repercussion of the disease in the daily life (5% of the mark)

Important:

- Students will pass the theory part of the test with the equivalent of 5 points out of 10. Passing the test is an essential requirement to pass the subject.

If any student has failed the test and passed the practice part, he or she would have failed the subject, but the mark of the practice assessment will be kept for the next call.

- Attending to the practices is compulsory. If the practices are not carried out by the student, his or her exam would not be not marked and the subject will befailed.

ADDENDUM COVID-19

This addendum will only be activated if the health situation requires so and with the prior agreement of the Governing Council

Siguiendo las recomendaciones del Ministerio, la Consellería y el Rectorado de nuestra Universidad, para el período de la "nueva normalidad", la organización de la docencia para el primer cuatrimestre del curso 2020-21, seguirá un modelo híbrido, donde tanto la docencia teórica como práctica se ajustará a los horarios aprobados por la CAT pero siguiendo un modelo de Presencialidad / No presencialidad en la medida en que las circunstancias sanitarias y la normativa lo permitan y teniendo en cuenta el aforo de las aulas y laboratorios docentes.
