### SUMMARY

The objective of this subject is to develop the knowledge and the working and communication capacity in the field of the analysis of the actualized information in the different aspects of the drug dependency. The incorporation of the new technologies of the information, communication and bibliographical search will contribute to those objectives. Among the formative activities, aspects related with the knowledge of the different psychoactive substances subject to be used that trigger modifications of the behaviour and of the perception in the human being will be included. Study of the temporal evolution of the drug in the organism, of its mechanism of action, interactions with other drugs, interpretation of its effects, behavioral disorders, social disorders and pathologies associated with the use and abuse of these substances and of the associated medical-legal problems.

## TEACHING METHODOLOGY

The **theoretical lessons** are based on the exposition, through the professor's master class, of the theoretical content of the subject from different angles: medical-legal, psychiatric and pharmacological. These lessons can be supported by audiovisual materials adapted to each unit. The students' participation will be encouraged.

In the **seminars**, the professor will set specialized topics in depth, case studies, bibliographical management, current topics... That will be linked to the different aspects related with the use of the different drugs, their historical use and the evolution of this use up to nowadays, the study of the drug kinetics with a concrete problems, concrete aspects of the psychiatric pathology and the study of the medical-legal problems related with the drugs abuse. The group work and the oral presentation will be encouraged.

The gender perspective and the Sustainable Development Goals (SDGs) will be incorporated into the development goals (SDGs) into teaching, whenever possible.

## **EVALUATION**

The theoretical-practical evaluation, the theoretical part represents 50% of the final grade of the course and the practical part the other 50%.

The evaluation of learning will be carried out in four sections (pharmacology, legal medicine, psychiatry and attendance to classes and seminars), each of these represents a percentage of 25% of the course.



The theoretical evaluation will be carried out by means of a theoretical exam of short questions and/or multiple-choice questions (test).

The practical evaluation will be carried out by means of a continuous evaluation through the attendance to seminars and the elaboration of individual works based on clinical problems and/or multiple-choice questions and/or short questions.

Students who do not pass the continuous evaluation, who do not participate or who have an attendance of less than 50% will have to take a final test (exam) that will consist of answering different development questions and/or multiple choice questions (test) in order to evaluate their acquisition of theoretical and practical knowledge.

In the multiple-choice exams, wrong answers and blank answers are not penalized.

It is a requirement for the student to have completed all the internships in order to be able to take the exams in advance.

Attendance will be compulsory (as indicated in the workload). Unjustified non-attendance to more than 20% of the classes will mean the impossibility to pass the course in the first call.

Students are reminded of the importance of carrying out the evaluation surveys to all the teachers of the subjects of the degree.
