SUMMARY

Social structure and General Sociology is a compulsory subject of basic character with annual periodicity that is placed in the first year of the degree. It forms part of the Sociology and Research Techniques subject block that aims to address training in sociological analysis, the concepts it employs, methods and research techniques.

This subject is also a necessary introduction to basic contents of other subjects such as "Culture, behavior and political actors", "Political economy", "Economy of the public sector", "Welfare state", etc.



It will offer a solid background in sociology and sociological analysis, combined with the study of the structure and dynamics of social change. The topics that will be addressed are: the sociological imagination, from tradition to modernity, culture and socialization, structuring elements, stratification and social classes, globalization. In the training of graduates and graduates in political science and public administration, it is a basic subject for understanding the social environment in which events and political phenomena take place.

TEACHING METHODOLOGY

Each theme of the program will be developed throughout different theoretical and practical sessions simultaneously. These sessions will have a part centered on the explanation of the concepts, dimensions, analytical interdependencies and key empirical data that the students must learn to manage. It will be the teacher who is responsible for the expository work but will seek to ask about the concepts, about the understanding and will provoke the participation of the students in spontaneous debates. The essential complement of this didactic strategy is the own personal active work that falls on the students, both individually and as a group.

The students will carry out a set of practical exercises and several activities that will be monitored by the teacher. In principle, and independently of its definitive concretion in function of the real possibilities in the group, the practical activities that are proposed are the following:

a) Reading of different texts and materials for their understanding and public discussion. Basically, these materials will be of two types:



- short texts, to read and work in class, which will aim to introduce a controversial or problematic aspect of the program's themes.

- texts of the basic or complementary bibliography of the subject, which must be read and worked on before the realization of certain sessions in the classroom.

b) Written activities of short length on some readings and other materials (films, documentaries, lectures, etc.) in which different exercises of bibliographic search, contrast, comparison, analysis, synthesis and criticism will be proposed, which must be solved sometimes individually and others in groups.

c) Completion of 2 group projects. The students, distributed in groups, will develop over a period of 6-8 weeks a collective work of analysis, synthesis and criticism, linked to the topics of study. These works will be the object of orientation, follow-up and supervision by the teachers. The results of the different works must be presented in, publicly exposed in the classroom in a synthetic way, and uploaded to the virtual space (AV).

d) As an alternative to one of the works of the previous point, the teaching staff can consider participating in an internal seminar of readings, carried out individually, from a list of books. The seminar will be developed as an open session of complementary activity in the schedule of complementary training activities, and/or in the classroom.

To carry out these practical activities, specific guidelines will be given in class and, if necessary, detailed guidance in tutoring. It is very important to point out the importance of tutoring as one of the central elements of these teaching strategies. Throughout the course, and in the hours of attention to students, group tutorial sessions will be developed sequentially to follow up on some activities or work more specifically on a specific issue. With regard to individual tutoring, and given the high number of people usually enrolled is important to note that here the initiative must start from the student.

Finally, it should be noted that in this subject we will have to use the Virtual Classroom. It is an Internet platform, facilitated by the University of Valencia to the entire university community, which allows document management and interconnection between teachers and students who share the same teaching group. In this platform, students can find study materials related to the subject and other important information, as well as participate in certain debate activities, deposit the practical work done and fill out their student file. Student access can be done through https://correo.uv.es or http://aulavirtual.uv.es, with the user's email and password provided by the University of Valencia at the time of registration.

EVALUATION

The fundamental part of the evaluation will proceed both (1) the exam or examns, with a weight between 60% and 50% (to be determined by the faculty in the Specifications to the Teaching Guide) and (2) of the exercises and practical activities that have been presented throughout of the course, with a weight between 30% and 40% (to be determined by the faculty in the Specifications to the Teaching Guide). (3) Active participation in transversal activities will be valued in third place, and active participation in class and reasoned discussion about the contents of the program throughout the course, with a weight of 10%-



20% (to be determined by the teaching staff in the Specifications to the Teaching Guide). In order to add the parts 2 and 3, the note of the part of the exam must be passed (5 out of 10).

Composition of the final grade:

- (1) Final exam: 60-50%
- (2) Exercises and evaluable activities: 40-30%
- (3) Active participation in class: 10-20%

Total: 100%

To determine the final grade of each student's work, the following procedures and criteria will be followed:

a) In general terms, the criteria for the correction of the submitted works will be the following:

* Individual works and activities: the appropriate formal presentation; the relevance of the materials and the data used for their realization; the analytical depth; the coherence and capacity for synthesis in the presentation of the arguments; the critical and reflective contributions raised.

* Work and group activities: the ability to resolve cooperatively the challenges that the group has faced during its implementation; the significant relevance of the documentary and empirical sources used to achieve the objectives of the work; the adequate presentation both orally and in writing; the coherence and capacity for synthesis in the presentation of the arguments; the critical contributions presented.

* For the activities in which a delivery period is fixed, the delivery in a later date to the indicated term will be able to be penalized in the qualification.

* The non-recoverable activities will be specified.

b) With the completion of the final exam is to systematize the knowledge acquired as well as the ability to analyze and interpret the data provided by the different dimensions and content covered by the subject. The exam seeks to assess the development and personal reflection on the topics discussed. That goes beyond the repetition of the contents learned. The general criteria for its correction will be: appropriate formal presentation; adequacy of the answers to the questions posed; coherence and clarity in the exhibition, analytical depth and originality in the critical and personal reflections exposed.

In order to add the different parts, the note of the part of the exam must be passed (5 out of 10).

Students who do not obtain the approved of the subject in the first call, may be submitted to the second following these criteria. For the second call it will not be necessary to repeat the practical work already done during the semester.

Although it is not mandatory, it is advisable to attend class work. All the

Teacher organization is organized on the basis of commitment to work and continuous assistance to the classes. The non-attendance to class will be penalized with a progressive criterion:



* Since to 5 absences: negative evaluation in the calculation of the note related to active participation in class, in a progressive mode.

* Since 9 absences: the participation in class or in the transversal activities will not be valued.

(Only in very justified cases may the absence will not be counted).

- 2. Prueba escrita abierta (examen tradicional) pero distribuido en aula virtual

4. Pruebas de evaluación mediante trabajos académicos

Para la ponderación de las notas para este 1er. cuatrimestre se aplicarán los porcentajes que se especificaban para el global del curso, tal y como se recogen en la Guía, así como, más concretamente, en las Especificaciones de cada Grupo (60-50% examen; y la resta evaluación continua, es a decir: 30-40% actividades y 10-20% participación. II.
