SUMMARY

La asignatura “Historia Contemporánea Universal” es una materia anual de primer curso del Grado de Ciencias Políticas y de la Administración. Sus contenidos se estructuran en torno a conocimientos generales de los grandes procesos históricos mundiales de la época contemporánea. En este sentido guarda relación con otras materias más específicas también de primer curso (como la *Historia Contemporánea de España y de las Instituciones jurídico-políticas*) o de segundo curso (como *Historia del pensamiento político*). Del mismo modo se complementa con la materia *Instituciones y políticas de la UE* de tercer curso.



En general, está pensada para ofrecer una serie de conocimientos básicos con los que afrontar materias más específicas en otros cursos.

El objetivo general de la asignatura “Història Contemporànea Universal” es adquirir unos conocimientos generales sobre la formación de la sociedad y la política contemporáneas a partir del estudio de los acontecimientos y procesos históricos más importantes que se produjeron a lo largo de los siglos XIX y XX. Aunque la materia abarca un espacio de referencia mundial, inevitablemente la mayor parte de los procesos que definen la sociedad contemporánea actual están referidos a la influencia del devenir histórico en lo que llamamos "Occidente". Por tanto, Europa y Norte América estarán consideradas de forma especial en estos procesos.

Con esta asignatura los estudiantes adquirirán conocimientos básicos del funcionamiento de las sociedades contemporáneas en base a los procesos históricos que las han formado. Del mismo modo, se desarrollarán habilidades prácticas para el análisis de estos procesos a través de fuentes primarias de uso común en la investigación histórica, como textos, mapas, imágenes, filmes, etc.

TEACHING METHODOLOGY

1) Classes, ie, regular classroom activity of the subject or group. These hours are distributed as follows:

1.1) Lectures: The instructor will present and explain those fundamental elements that should guide students in the study and understanding of subject matter. The student, meanwhile, should actively engage in the learning process through reading, before the teacher's explanation, or in class, depending on the organization of teaching time, those materials, manuals, monographs and texts provided or previously indicated.

1.2) Practical classes: They will deepen, through various materials (historical texts and / or historiographical, movies, documentaries, etc.) in those areas deemed most important or significant issues. The materials will be delivered in advance by teachers to students or tell them where they should proceed encontralros and preparation. These classes will be participatory and students assume, and



alternatively rotating the responsibility of his statement, comment or whatever the teacher deems appropriate and convenient. The preparation and participation in practical classes will be required and evaluated. The sessions will be used to gradually introduce and accustomed to the students in the handling of those materials and techniques of the discipline of history.

2) Attendance at tutorials unscheduled:

2.1) Students in a group may attend the office hours for students who have scheduled every teacher to inquire about any topic or aspect of the subject and, where appropriate, the work being performed. Operating hours the student and the tutoring activity must be assumed and seen as a continuation of the activity or the act of teaching and must lose, therefore, its exceptional or outstanding for both the teacher and the student.

2.2) Where applicable, these queries can also be submitted via e-mail, within the available time and criteria established by the teacher.

3) scheduled tutorials. In his case, the teacher shall carry out a series of interviews with students, if appropriate or necessary to:

Monitoring of work and student learning.

Monitoring and control of readings and other activities.

4) Follow-up or cross. In their case, they may also be programmed within the teaching, specific activities of the subject or interdisciplinary or cross, in coordination with the groups of the same subject or other subjects that help to deepen in some issues or problems deemed of interest. For these activities will be available teaching and administrative organization will be judged appropriate and timely in the context of the learning process.

EVALUATION

The evaluation of the course will have the following forms:

- Written test and / or oral exam consisting of theoretical questions. This test will be worth 70% of the final grade.
- Evaluation of activities designed and evaluated in class. These activities will be worth 20%.
- Evaluation of cross complementary activities and the group made by different teachers of the course. The total of these activities will be worth 10%.
