SUMMARY

The subject has two main general objectives: to bring students closer to the knowledge of the local environment as an operational framework for the local approach to development (local government and governance, actors and social networks) and, on the other hand, to the instruments and policies for the design, management and/or application of the local development strategies in which this approach is embodied. Local development, conceived, managed and/or implemented from the local level, by local actors and for the local population, constitutes a complementary approach to traditional approaches, with the added value of sustainability as a reference. Local-sustainable development is embodied in development strategies, which project the strategic vision of the territory in question, with the aim of advancing the sustainable socio-economic development of local society. These strategies, although applied at the local level and with an essential role for local governments (in a context of direct participation of local actors -governance- in local development processes), are channelled through different operational and political instruments, emanating from the EU scale to the regional one, and where appropriate, the local administrations themselves, always with sustainable local development as an



objective.

PREVIOUS KNOWLEDGE

Relationship to other subjects of the same degree

There are no specified enrollment restrictions with other subjects of the curriculum.

Other requirements

Students should have an instrumental knowledge of foreign languages (like French, English, German, etc.) that allows them to read and understand any documents or texts written in these languages.

Knowledge of office automation systems to deliver exercises, resumes, etc. in a digital form, even to prepare oral presentations with Power Point, for instance.

Effectively use web-based platforms (such as official organizations: United Nations, Instituto Nacional de Estadística, etc.).

TEACHING METHODOLOGY

CLASSES: an explanation will be made through presentations of various theoretical contents of the syllabus.

PERSONAL STUDENT WORK: reading articles and documents.

PREPARATION FOR PRACTICAL WORK.

REALIZATION OF TEAMWORK: Part of practices must be done as a team. Part of class time will be devoted to the implementation of these practices.

TUTORIALS: a) Scheduled: In these tutorials the teacher will explain the specific contents to be developed by each working group. In addition, various tutorials will be scheduled in order to prepare course work; b) Unscheduled: they will be dedicated to answer questions that might have arisen during the development of classes. There will also be face-to-face and on-line (Moodle or e-mail).

COMPLEMENTARY ACTIVITIES: Several options will be proposed at the beginning of the course, if any, the possibilities that both other subjects of the Degree as well as the reality of the Valencian territory allow. If done, this part of the subject is understood as continuous evaluation and cannot be recovered if it is not done at the moment in which it takes place.
