SUMMARY

En la asignatura se explica el origen, consolidación, evolución y crisis del Estado de bienestar, tratando siempre de mostrar los elementos políticos, sociales y económicos presentes en los distintos procesos. Para ello, se analizará el concepto y fundamento (estatalización de la sociedad y socialización del Estado) del Estado de Bienestar, para luego revisar la distintas interacciones entre actores políticos colectivos que se han dado desde el surgimiento del Estado Social, hasta la actual crisis del Estado de Bienestar. Como elementos específicos, se estudiarán los distintos modelos de Estado de bienestar.

Se trata de una asignatura que tiene contenidos de carácter transversal que explican los diferentes momentos del Estado de Bienestar, a saber: la evolución de los procesos de Modernización e industrialización, las tendencias demográficas, el proceso de globalización y la evolución de los sistemas de seguridad social.

The composite grade is based in 2 elements, both in the first and in the second exam periods:

- a) A final exam: at the end of the course a final test will be carried out on all the contents of the course, whether they have been taught in the classroom or not. The exam will also include the materials that are included in the different sessions. This test will have a value of 60 percent of the overall score. The student must have achieved at least a 4 (out of 10) in order to compute the score of the assignments made in the class along the course.
- b) Assignments in the class: Throughout the semester will be made different exercises and complementary activities of various kinds to be delivered in presence the day of the course (some of them require that the student has previously worked on the materials indicated by the teacher). The content of these exercises in class also constitutes materials and susceptible to be part of the end-of-course test, regardless of whether the student has done and well all the deliveries. The overall score of these exercises will have a value of 40 percent of the final grade (dividing equally (20%) between the two seasons of the course in case of annual subjects). The teacher will spaeify in advance which exercises are evaluable.

The non-delivered exercises will not be recoverable later or for the second call.

HYBRID TEACHING
