SUMMARY

The subject Constitutional and Administrative Law is of basic formation of the 1st annual course and It consists of 9 ECTS credits with the following academic distribution: Constitutional Law, 4.5 credits and Administrative Law, 4.5 credits. In the first semester will be taught Constitutional Law and in the Second Administrative Law.

The first part of the subject is an introduction to the essential contents of the organization political and territorial state. Therefore, the essential contents that are conformed are addressed for the Spanish Constitution. Organization of the State. Human rights. Fundamental rights and public freedoms.

The second part constitutes an approach to Administrative Law and its institutions central, focused on the most relevant for the degree of Criminology. In addition to the origin and evolution of the discipline, the position of the Administration before the law and the judge is analyzed; the powers of the Administration, in particular, the sanctioning; the act and the administrative procedure as well as police administrative competences.

The individual or collective works, realization of practical cases, seminars, participation in classes, all of them face-to-face; participation in external activities will represent 40% of the final grade of this block.

2.- Administrative Law (corresponding to the second block). The evaluation will consist in the realization of a final exam written in the date that officially is determined (that will suppose a 60% of the note). The presentations of work and resolution of cases by the students and their participation in class will be taken into account, assuming 40% of the final grade of this block.
