**TEACHING METHODOLOGY**

The classroom hours will be distributed between theoretical classes given by the lecturer and, depending on the characteristics of the group, practical activities, which may be activities related to the contents, oral presentations, etc. Likewise, the practical part of the course, which is not face-to-face, may consist of the elaboration of academic papers, reviews, dossiers of the activities or the preparation of a written test, a written test on them, etc. (see section on Evaluation).

**EVALUATION**

Evaluation tests percentage:

- a) Practical exercises: 25%.
- b) Written examination on the contents of the programme: 75%.

Remarks:

- 1) The minimum final mark to pass the subject is 5 out of 10.
- 2) The minimum mark that must be obtained in each of the parts a) and b) is 4 out of 10, in order for the marks to be weighted to obtain the final mark.





The same criterion shall apply to the different tests that may be set in sections a) and b) in order for the marks to be weighted in order to obtain the final mark. The teaching staff will determine at the beginning of the course the obligatory or optional character to pass the subject of the different practical exercises established in the block a).

- 3) The teacher shall establish the type of written examination (part b), 75 % of the final mark.
- 4) The teaching staff shall specify throughout the academic year the nature of the practicals (part a), 25 % of the final mark). The practicals may be activities on the contents of the subject, the preparation of a dossier on the same or the preparation of a written test on the same, the carrying written test on them, academic work and oral presentations, etc.
- 5) In the written tests, one of the evaluation criteria will be linguistic and orthotypographic correctness. Deficiencies in language, spelling and presentation may be grounds for failure.
- 6) In academic work, if any, originality is an exclusive criterion. Plagiarism from Internet or other sources may be grounds for failure.
- 7) Those tests which, due to their nature, allow it, such as the exam, will be recoverable, academic work, activity reports and practical reports will be recoverable. Those tests that due to their nature are not recoverable, such as, for example, oral presentations in class, will not be recoverable. Grades obtained in non-recoverable tests will be maintained until the second call.
