SUMMARY

Introduction to the theory and practice of literary and audiovisual translation of texts in English, with special emphasis on the translation of dramatic dialogue, both in stage plays and in scripts of films and TV programmes to be dubbed and subtitled.

- Draft a report containing an analysis and assessment of a translation performed by applying knowledge in translation studies.
- explain the principles, priorities and constraints of dubbing and subtitling.



DESCRIPTION OF CONTENTS

- 1. 1. Analysis and translation of literary texts: detecting and solving translation problems involving linguistic variation (register, dialects, chronolects), cultural elements, humour, ideology, tone and style.
- 2. 2. Analysis and translation of audiovisual texts: priorities and specific constraints in dubbing and subtitling: interaction of image and sound with words, synchronization,
- 3. Basics of criticism and assessment of literary and audiovisual translation.
- 4. Specific strategies for verse translation.
- 5. Translating dialogue for performance.
- 6. Introduction to professional aspects of creative translation: conventions in dubbing scripts, agencies, associations, tools.

TEACHING METHODOLOGY

Theory-based classes: lectures and case studies.

Lectures will focus on clarification and discussion of key concepts and techniques rather than on exposition of matter students can find in the dossiers and bibliography. Consequently students are expected to work on assigned tasks (reading sections from course dossiers, answering questions set in advance) before attending class.



Practical classes: problem solving and case studies.

Other activities: tutorials for orientation in preparing papers and projects.

EVALUATION

The assessment for both the first and second calls will be carried out through a set of individual written assignments to be agreed with the lecturer.

These assignments may include:

- -translation practice of assigned literary or audiovisual texts, including an explanation of the translation principles, procedures and choices employed
- -questions on the contents of the course,
- -critical reviews of published translations.

Marks for assignments passed in the first call will carried over to the second call, and only failed assignments will need to be retaken.

The ability to communicate at the C1+ (CEFR level) is required to pass the course as a whole. Students whose communication (written and/or oral) displays errors that are not consistent with the above level will fail the module regardless of their performance related to the course contents.

Plagiarism will not be tolerated; it is a serious academic offence. Any student who is found to have plagiarised his/her work will fail the whole subject.
