SUMMARY

This course belongs in the third year of the Catalan Philology Degree. It focuses on the twelfth- to fifteenth-century poetry. It is a continuation, and complement, of courses Medieval and Early-Modern Catalan Literature, and Medieval Catalan Literature I.

PREVIOUS KNOWLEDGE



Relationship to other subjects of the same degree

There are no specified enrollment restrictions with other subjects of the curriculum.

Other requirements

A satisfactory knowledge of courses Medieval and Early-Modern Catalan Literature, and Medieval Catalan Literature I is assumed. Total fluency in Catalan language and its grammar is expected, as is a good written performance in academic essays.

TEACHING METHODOLOGY

Teaching methodology will aim to conciliate theoretical and practical activities. It is considered theory exposition on historical, cultural and contextual contents needed to understand and analyse our texts. Commented readings on poems, and subsequent search for its explaining reference points are considered practice.

The course's professor will facilitate use of Aula Virtual (Virtual Classroom), and through it students will access texts, as well as receive communication of incidences. The professor will also receive students in her study room (083) within tutorial hours (displayed on the Department Secretary board) for consultations related to class matters.

Theoretical teaching:



Within theoretical teaching, the course's professor will explain historical-cultural context and rhetorical elements from which the authors' poetic work is conformed. Lecture method will be interspersed with the student's comparative text study and analysis from a historical-cultural perspective.

Practical teaching:

Practical teaching will aim to reading, linguistic understanding and rhetorical-poetical analysis of texts, according to history of culture patterns. What has been learned from the specific bibliography (facilitated by the course's professor) will apply also here.

EVALUATION**Evaluation criteri****Theory**

A written test will take into account and evaluate the students' knowledge of the course's theoretical matter. Students will answer in different essay-type forms about aspects of themes seen at the classroom. Students should show acquired knowledge on the subject matters as well as competence of academic texts' composition. This part will constitute 70% of the final mark.

Practice

Competences on matters learnt in practical classes through the term will be evaluated and, in a written test, by answering text-commentary-type questions, in which student should show their level of understanding of the poems on which they have worked at the practical classes. This part will constitute 30% of the final mark

Naturally enough, incomprehensible (impossible to understand) essays will not obtain marks, and grammatical errors will be severely penalised. In accordance with the Departament de Filologia Catalana's guidelines, grammatical errors in tests will mean automatically a D or E in the final mark.
