SUMMARY

La asignatura aborda el estudio filológico integral —lingüístico y literario esencialmente— de la prosa clásica, en concreto de la historiografía latina, especialmente la clásica, mediante la lectura, traducción y comentario de textos de pasajes de Salustio y de Tito Livio preferentemente. Por la parte lingüística se incidirá en el conocimiento del verbo latino y, por la parte literaria, en el conocimiento de la prosa historiográfica, tanto en sus aspectos teóricos cuanto sobre todo prácticos. Las lecturas de las fuentes antiguas o estudios modernos sobre estos temas formarán asimismo parte del horizonte académico de la asignatura.

TEACHING METHODOLOGY

- Clases teóricas: exposición de los temas correspondientes al contenido lingüístico de la asignatura.
