SUMMARY

The subject consists of the reading and translation of Ionian prose texts, of medium difficulty, for their interpretation within their literary and cultural context, with the aim of broadening the horizons of the reading of classical Attic prose. The subject involves a progressive assimilation of basic concepts of the Greek language and requires the acquisition of basic and specialised vocabulary. The proposed literary genre is historiography, specifically Herodotus. This subject is the logical development of Greek I, II and III, and the previous step to Greek V and VI, since all of them are the basis for the translation of prose texts with a view to the student's basic and specialised training.



PREVIOUS KNOWLEDGE

Relationship to other subjects of the same degree

There are no specified enrollment restrictions with other subjects of the curriculum.

Other requirements

Basic knowledge of the Greek language and possess the basic tools for the translation, with a dictionary, of Greek prose texts of medium difficulty.

TEACHING METHODOLOGY

1) In the classroom:

Translation by the students, correction and commentary by the teacher.

Theoretical classes: syllabus.

Observations: Students have to prepare the texts at home and come to the classroom with their personal translation.

2) Work outside the classroom:

- a) Preparation of the texts to be read in class.
- b) Translation of a group of texts, to be indicated at the beginning of the course, with the help of other translations and commentaries.
- c) Complementary reading.
- d) Study of the syllabus.

EVALUATION

There will be a single exam, with limited dictionary tense, which will consist of an analysis and translation part and a commentary part and will be worth 70% of the mark. The exam may include a question on the theoretical syllabus covered in class.



The rest of the percentage of the final mark (30%) will be distributed as follows:

- 10% Active participation in class.
- 20% Evaluation test of a selection of texts that the student will have to prepare on his/her own throughout the semester. This exercise will consist of a text to be translated and commented on.

In order to obtain an average and pass the course, it will be necessary to obtain a minimum of 4 out of 10 in the final exam. The grade for active participation in class will not be recoverable in the second exam.
