TEACHING METHODOLOGY

Teaching will combine theory and practice.

Theoretical classes: These will consist of expository sessions on the indicated topics that make up the subject so that students acquire basic general skills in the different areas of study indicated and a more specific and detailed knowledge in the cases of some authors, currents or phenomena that are essential to understand the transmission and reception of classical culture in the West.

Practical classes: Work with texts from different periods and authors on the practice of translation from the ancient world to the present day, with the legacy of classical culture as a common thread. The motifs of the classical tradition in art and, in general, the culture of the various stages of the chronological path indicated will also be taken into account.
