HYBRID LEARNING MODE (BLENDED)

1. Contents

The contents of the subject remain unchanged.

2. Workload and teaching schedule

The weight of the activity originally contemplated in the teaching guide is modified in order to facilitate complete face-to-face access to each student in groups A and B to each of the subjects taught. This will not imply in any case an increase in the student's workload, which will continue to be 6 ECTS. The class schedules and classroom assignments prepared by the center are maintained at all times.

3. Methodology

The teaching modality will be a weekly hybrid in a semi-presential asynchronous format. This implies that the curriculum will be taught for both groups in alternate weeks. The online connection of the group of students who remain at home that week will not be necessary at any time, and the whole group (A and B) will have access to the same classes under the same teaching conditions.

4. Assessment

The examination will be carried out in person on the dates and under the sanitary conditions established by the center for this purpose. In this exam, the student will be able to have all the bibliography (notes, references, etc.) that he/she needs. This evaluation format also allows the confined student, whether from group A or B, to carry out the examination at home.
