## SUMMARY

In this course, which is predominantly practical in nature, the linguistic divergences between the French and Spanish languages will be studied through the analysis of French texts and their translation into Spanish.

The course allows students to deepen their ability to define criteria for contrasting interlinguistic differences in order to apply them to translation, and It also contributes to the theoretical and practical knowledge of the B and A languages selected by the student.

### **EVALUATION**

#### **EVALUATION**

The evaluation of the course, both continuous and final, will consist of two different parts:

- 1) Written exam 70% of the grade on the theoretical and practical contents of the subject.
- 2) An individual work 30% of the grade to be presented in class and delivered by AV.

In order to pass the course as a whole it is necessary to achieve at least 50% in both sections and to hand in the work before May 16. Late papers will not be accepted and the grade will be 0.

Students who cannot attend class must notify the teacher at the beginning of the term.

For the assessment at the second call, the percentages are maintained. However, the work in class is not to be recovered, so the grade obtained by the student in the first call will be maintained. The only way to improve the final grade is by written exam.
