SUMMARY

The course is part of the General Philological Training module and the subject *Language*.

It is conceived as a general training course, in all the above-mentioned degrees, to provide students with competencies in the knowledge and handling of the cultured norm of Spanish in all its aspects (grammatical, orthographic, orthological, etc.), so that they can reflect on the doubts and difficulties that arise in the current use of the language and analyze the causes that promote the most frequent grammatical deviations.

The course *Norma y uso correcto del español* will focus, therefore, on the study of current Spanish, focusing mainly on the linguistic variants considered correct and the frequent deviations that occur around these forms, analyzing the possible causes that promote the use of erroneous structures in the users of the language, without losing sight of the current situation of Spanish in all its varieties and its international projection.

It will also deal with problematic issues related to oral expression and prosody of Spanish, orthology and spelling (mainly accentuation), as well as the correct use of words and the creation and development of neologisms, especially the difficulties of adaptation of foreign words and other problematic lexical aspects. Aspects related to stylistics and socially correct language will also be dealt with, as well as orthotypography guidelines for the creation of written texts and the writing of academic texts will be provided. Finally, students will be provided with information on current resources that allow the language user to deepen their knowledge of the correct uses of the Spanish language.

This subject is particularly relevant to SDG 5, and specifically contributes to "End all forms of discrimination against all women and girls everywhere", especially related to chapter 7 of the syllabus.

TEACHING METHODOLOGY

The teaching and learning methodology is articulated around two types of activities (face-to-face and non-face-to-face):

(a) The **face-to-face training activities** (representing 40% of the ECTS credits, 2.4 credits, 60 teaching hours). These training activities will mainly deal with the current academic regulations in force in the Spanish language (rules related to grammar, spelling, registers, etc.) and the uses that deviate from the norm, as well as issues related to pronunciation, correct oral expression and orthology; which will be the basis for the design of the exercises and practical activities.

1) Theoretical contents on each of the topics of the program, according to the specific development specified in each of them, supported by the reading by the students, prior or simultaneous to the explanations in class, of the recommended works or various texts provided.

2) Practical contents consisting of the commentary of the basic bibliography and the analysis of texts for the exemplification of the considered aspects.

b) **Non-face-to-face activities and tutorials** (representing 60% of the workload, i.e. 3.6 credits, 90 hours). This personal work may include the elaboration of individual or group work on normative issues, the resolution of activities and the preparation of the final exam. All this work involves bibliographical consultation and critical reading of texts representative of these issues, the promotion of a reflective spirit, the active involvement of the student in the process of building their knowledge of normative grammar, among others.

Some of the activities carried out during the course correspond to those approved by the SFPIE of the UV in the PíEE "LANGUAGE. Equal communication: academic writing practices in higher education" and with the PíEE DTD_iLAB: Collaborative learning through interdisciplinary projects (third phase).

The Virtual Classroom will be used to provide support material for classes and presentations, as well as to keep students informed of notices, instructions and announcements of interest that are published and as a forum for communication between the different members of the group (teachers and students). This platform will also be used to carry out certain activities.

Each teacher will detail the activities of his/her group at the beginning of the course, through the Virtual Classroom.

EVALUATION

In this subject the evaluation system will be based on the control of the skills that the student must acquire (theoretical knowledge and writing and proofreading skills in Spanish, from the point of view of the academic standard).



In general, the evaluation of student learning will be based on a combination of a final exam and practical activities:

- (a) The type and structure of the final exam will consist of short questions. The exam will consist of a series of multiple-choice questions.
- b) The type and number of practical activities will consist of the resolution of exercises on a topic or a specific question on the cultured norm, exposition and critical reflection of a normative problem, questionnaires, completion of a final paper, etc.; as well as practice in the drafting and composition of an oral or written text. These activities are related to the contents of topics 2, 3, 4, 5, 6 and 7.
- The final grade will be the sum of the grades obtained throughout the course in the previous concepts, which described in percentages is as follows:

First call

60 % exam.

40 % practices:

20 % Practical activities carried out through the Virtual Classroom or in class. **ACTIVITY NOT RECOVERABLE.**

20 % Academic work based on the basic works of reference. **RECOVERABLE ACTIVITY.**

Second call

60 % exam.

40 % practicals:

If the internship has been passed, but not the exam, the internship grade obtained in the first call is kept. If the practical part has been failed, these can be recovered by applying the following percentage: 40 % Academic work based on the basic reference works.

To pass the subject as a whole, both in the first and in the second call, a 5 out of 10 (3 out of 6) must be obtained in the exam so that the practices can be counted and an average of 5 in total.

Observations:

1. Throughout the course, knowledge acquisition controls could be carried out.
2. As a means for the evaluation and for the personalized communication (in private) of the results of this, the Virtual Classroom platform will be used.

The general grading system will follow the regulations of the Universitat de València approved by the Consell de Govern on May 30, 2017. ACGUV 108/2017.
