Sciences**SUMMARY**

Linguistics is a core subject in the degrees in Arts and Humanities. The reasons are obvious: the knowledge of the functioning of the linguistic system is of utmost importance for any of the areas of life and work where humans must perform through oral and written interaction.

For this reason, the contents and learning outcomes of this subject are essential for professionals who wish to train in the field of knowledge of the Arts and Humanities. Linguistics goes beyond the knowledge of a language since it has been conceived from the assumptions of a science and, therefore, its purpose is to collaborate in the promotion of an informed knowledge about its properties as a scientific discipline and the complexity of its subject of study: human language.

This dimension guides the contents of this subject. On one hand, it is about providing knowledge and comprehension of the theoretical and applied foundations that govern the functioning of a language. And, on the other hand, incorporating into the students' general philological training the resources that will allow them to offer society the best and most effective solutions to the communicative and linguistic needs of the speakers, in those fields of action in which they will be integrated into the labour market.

TEACHING METHODOLOGY

The development of the subject is structured into two weekly sessions of two hours each, which will be divided (as far as possible) into theoretical and practical sessions, enabling teachers to dedicate sessions to those aspects that may require more attention at their discretion.

During the course, some sessions may also be devoted to activities such as attending conferences, workshops or lectures related to the syllabus and the students' linguistic training, if required. The rest of the distribution of hours dedicated to the course can be consulted in the previous section 7, entitled Workload.

EVALUATION

Assessment will consist of two different parts. One related to the theory explained in class or, where appropriate, intended to be developed by the students on their own. The other is related to the practical activities carried out during the course or, where appropriate, proposed to be carried out by the students on their own. All training activities promote most of the general and specific competences presented in the section 3.1. of the document "Verifica", which corresponds to the basic subjects of the branch of Arts and Humanities.

Evaluation criteria:

Theory:

- Assimilation of the contents of the subject.
- Conceptual and terminological mastery of the subject.
- Expressive, grammatical and orthotypographic correctness in the different types of tests.

Practical work:

- Assimilation and application of the contents of the subject to practical activities.
- Conceptual and terminological mastery of the subject in practical activities.
- Expressive, grammatical and orthotypographic correctness in the different types of tests.

Evaluation tests % of the final mark

a) Test on the contents set out in the course syllabus 60%

b) Practical activities planned by the teaching staff 40%



Considerations

- 1) The minimum mark that must be achieved in blocks a) and b) is 4 out of 10. Otherwise, the corresponding weighted marks will not be added when calculating the final mark. The same criterion will be applied to the evaluation processes that may be established by the teaching staff in each of the blocks. The minimum overall mark to obtain a passing grade for the subject is 5 out of 10.
 - 2) In case of not doing all the activities described in blocks a) and b), the overall grade of the subject will be *Absent*. This same criterion will be applied to the assessment procedures that may be established by the teaching staff in each of the blocks.
 - 3) Test on the contents set in the syllabus of the subject (a). The teaching staff of each group will establish the nature of the test (written exams on the contents explained during classes, tests on the compulsory readings that may be proposed, oral exams, etc.) as well as the deadlines or exam dates. Unless the teaching staff stipulates otherwise, the exam dates for the first and second calls will be that established officially by the Faculty of Philology, Translation and Communication.
 - 4) Practical activities (b). During the teaching period, the teaching staff of each group will establish the nature of these activities. Each teacher will communicate at the beginning of the course the activities that will be carried over to the second call.
 - 5) In the written work that may be proposed by the faculty, originality will be an exclusive criterion: the direct copying of texts from the Internet or other sources (i.e., plagiarism), except for the standardized mechanisms of citation, will imply a substantial decrease in the grade and even the failure of the work. Among other aspects, the application of the contents of the subject and the methodology, the adaptation to the genre, the skills in relation to writing, the clear expression of contents, style, grammar, orthotypographic correction, presentation and layout, etc., will be assessed. At the teacher's discretion, deficiencies in spelling and grammar or in presentation and layout may be grounds for failure.
