# **TEACHING METHODOLOGY**

### A) Presencial activities:

In the theoretical-practical classes we will use a hybrid model that combines the expository and the communicative didactic model. The expository model uses explanatory methods that focus on showing the interdependence between concepts and facts, and includes the repeated use of different skills. The focus is on conceptual content and basic skills are emphasized. Verbal interaction between teacher and student is fundamental. In the communicative didactic model, the teacher guides and dynamizes learning through methods of dialogue, discussion and problem solving within a climate of interaction among equals. The student learns empirically in relation and interdependence with the teacher and the rest of the classmates, sharing perceptions and ideas about reality and collectively reconstructing knowledge. Learning is centered on discovery, understanding the logic of the subject matter and the social, cultural and ethical problems that derive from it.

Other activities such as attendance to seminars, readings, performances, conferences or courses, dedicated to different artistic fields, will complement aspects of the syllabus.

### B) Out of class activities:

Since students are in possession of the reading dossier and the list of required readings from the beginning of the course, they will be able to (and should) prepare the readings in advance, for later discussion in class. Students should attend the theoretical classes having read the material recommended by the professor for each session. The student must also learn to work autonomously, making use of resources such as the Internet, Virtual Classroom, bibliographic resources on paper and online, etc. and thus contribute to their own construction of part of the course content -always supervised, of course, by the professor in his tutorials-. Likewise, working with peers, i.e. in a group, will be a way to foster an attitude of discovery and criticism towards oneself and the profession and will serve to reinforce their communication and argumentation skills. Preparation of individual work under the direction and supervision of the teacher. Study, completion of individual or group work and exercises, tutorials, preparation of scheduled discussions and various continuous assessment tests, preparation and completion of the final exam.



## **EVALUATION**

In order to pass the course as a whole it is necessary to achieve at least a 5.0 in the written exam and in the written work.

In case of failing (or not presenting) the first partial may be recovered in the final exam in the first or second call.

### Evaluation criteria

Individual written test/s (on the dates officially determined), which will evaluate the assimilation of knowledge exposed in the theoretical classes and the student's capacity to relate this knowledge with the primary sources. The written tests are recoverable.

Individual written work (supervised by the professor). The skills of bibliographic and information search, the temporal organization of the work done and the organization of the ideas and arguments expressed will be taken into account. In case of plagiarism this assignment will be assessed with zero points. This activity is recoverable.

The faculty reserves the right to request an interview with the student once the individual work has been handed in.

Scheduled debate (on the date to be determined at the beginning of the course). It will consist of the oral presentation/exposition in group of aspects/topics related to the texts read in class, supervised by the professor. As in the written work, the organization of the ideas and arguments expressed, the ability to relate theoretical ideas with the required reading of a text, as well as the students' ability to express themselves and communicate will be taken into account. This activity is not recoverable.



In case of plagiarism, the paper or assignment will be assessed 0 points. Plagiarism:

- using another's work or part of another's work as one's own;
- copying one, several sentences, paragraphs or entire pages from an article, book, a web page, etc. WITHOUT marking it as a citation and WITHOUT specifying the complete reference(s), considering it/them as your own.
