SUMMARY

Italian Literature and Culture I is taught in the second term of the first year. Together with the subject *Introduction to Italian literary texts*, it is the students' first approach to Italian literature.

The course will be taught in Italian and will be adapted at all times to the students' expected level of competence (level A1 of the CEFR framework at the end of the course).

The syllabus covers Italian literature from its origins to the Renaissance. It is therefore a central period of formation and consolidation of a culture, a literature and a literary language that will give rise to the fundamental texts of Italian and world literature.

OUTCOMES

TEACHING METHODOLOGY

The teaching methodology seeks, above all, the autonomy of the students and their active participation in the classes and in learning, which is why techniques and resources aimed at practice, enquiry and research are promoted, as well as stimulating the student's motivation and interest in Italian literature and its context. The methodology, therefore, is based on the constructivist approach to learning, i.e. on the construction of new knowledge through the reworking and modification of the student's previous knowledge. In this way, meaningful learning is encouraged, favouring critical reflection on an individual level, but also on a collective level through critical commentary on the works and the sharing of learning elements.

Different methodologies will be used to organise the knowledge and work of both the teacher and the students: lectures, seminars, inverted class, participatory activities (online questionnaires, gamification methodologies, participation in the forum, exhibitions), collaborative work, use of the virtual classroom as a repository of material used for the classes and as a vehicle for communication between students and between the teacher and the students, as well as different technological resources appropriate in each case and with a specific purpose. A fundamental and essential part of the course will be the reading of compulsory texts and some complementary texts, so that the students will approach the literary fact and, in particular, the Italian literature of the centuries studied. Theoretical and practical classes will complement each other and from the two types of teaching the student must acquire the compulsory knowledge established in the syllabus. Cross-curricular activities will be proposed that will enhance the students' knowledge and skills. Work in the Virtual Classroom will also be fundamental to complement and deepen learning. Complementary cultural activities that may arise throughout the course will also be used, which may be recommended or compulsory as indicated by the teacher. In addition, learning to carry out scientific and academic quality work will be encouraged and plagiarism will be penalised. Plagiarism is totally prohibited and sanctioned in all work of any type and the mark for plagiarism, if verified, will be equal to 0, and may even fail the course.

Students must be very clear that, in this subject, they cannot limit themselves to taking notes in class and maintaining a passive, receptive attitude. This is not the objective pursued, nor is it in accordance with the



teaching methodology, which is active for the students. All the activities of the subject must be carried out in order to obtain a good result, but it is essential that the students work with maturity and responsibility. In class, students are expected to be participative, to express their doubts and progress, to express their opinions freely, but always with criteria and a critical point of view. Students are also expected to fulfil their obligations: readings, activities, comments, questionnaires, tests, quizzes, tests of different kinds, etc. All of this will result in the acquisition and understanding of the contents of the subject so that the proposed objectives can be met: the learning of the contents.

EVALUATION

The evaluation will consist of 3 distinct parts:

The written exam will be done from the virtual classroom applications that the teacher will indicate, generally from questionnaires, so it is important that students come to the exam room with a device that allows them to access the exam online. In any case, the teacher will have the same exam paper to avoid unforeseen circumstances.

The written exam will consist of three parts:

A test part, worth 30% of the exam mark.

A part of development questions, worth 40% of the total exam.

A part devoted to commentaries on the texts explained in class and read by the students (both compulsory readings and texts read and commented on in class) and relating them to the movements, themes, forms and structures of the authors and literary movements studied. This activity will be worth 30% of the exam mark.



The continuous assessment of the subject will include all the activities carried out by the students during the course: participation in the classes with interventions, questions, doubts or comments related to the subject syllabus, creation and maintenance of a class diary in the AV Forum, and participation in the AV Forums activities indicated as Homework in AV completion of questionnaires completion of Kahoots attending lectures, conferences and extracurricular cultural activities, transversal activity.

The Portfolio will be carried out in groups of 4 people and will consist of the creation of a newspaper in which the themes, authors and works of Italian literature covered in the subject will be presented as news. The work must have a newspaper format, with headlines, news, images and will include different sections just like a contemporary newspaper: culture, hobbies, last minute, even interviews, advertising, etc. and everything that is needed for the work to convey the use of the contents of the subject. Creativity is allowed, but respect for authors, works and historical, social and cultural events will be maintained, as well as the veracity of all the data included.

In the second call, the percentages are maintained and the grades of the activities performed and passed are kept. However, the activities performed in the classroom are not recoverable. Plagiarism is not allowed. Any work that presents plagiarism will have a grade of 0, and the student may fail the course.

Intellectual honesty is vital to an academic community and for the fair evaluation of the student's work. All work submitted in this course must be originally authored by every student. No student shall engage in unauthorized collaboration, copying of previously submitted papers or make use of ChatGPT or other AI composition software.
