TEACHING METHODOLOGY

EVALUATION

The assessment shall consist of two distinct parts:

Type of assessment

a) Individual written exam

Control of the acquisition of the points studied in class 70%

b) Individual work of initiation to research in linguistics 30%

In order to pass the course as a whole, it is necessary to achieve at least 50% of the mark in each section of the evaluation. The introductory research paper must be handed in before the exam.

The acquisition of the concepts studied in class and the application of these concepts to practical cases will be assessed.

IMPORTANT: Only the part of the assessment not passed in the first (work or final exam) will be recovered in the second call.
