SUMMARY

The compulsory subject Narrative studies in the French language is taught in the 2nd semester of the 2nd year of the Degree in LML. It is the 2nd of the 5 subjects of which the subject is composed Studies in French language literature, taught in 2nd, 3rd and 4th year. The purpose of this subject is to deepen the knowledge of the literatures of French expression. This subject completes the objectives achieved in the 1st subject of the subject Comments of literary texts in French language that develops during the 1st semester. This subject will focus on the study, analysis and commentary of narrative texts of different types, with special emphasis on those that show an innovative character. It is therefore intended to articulate a heterogeneous approach through the different texts to some examples and currents that show the concerns of the different authors of French expression through their novels or stories. The teacher will try to highlight the most important lines that illustrate the evolution of French narrative, granting special importance to contemporary texts. This synthesis comes from a thematic and representative choice of the most disruptive currents, trends, movements or individuals in order to privilege the vision that a student of today has of the world, to give coherence to a whole series of complex phenomena in the world.

TEACHING METHODOLOGY

The acquisition of theoretical and analytical knowledge will be carried out through active reflection that students will develop from documents and specific texts with the help of the teacher. It will therefore start from the practice of explanation in the context of narrative texts, subsequently addressing the analysis and textual commentary to arrive at overall considerations on the production of the narrative in the French language, while indirectly enhancing the practice of the French language in use and the acquisition of written and oral comprehension and expression skills. Regarding the distribution of teaching hours, the development of the subject is structured around 4 theoretical-practical teaching hours per week for all students.

EVALUATION

1. Evaluation in first call (students who have attended a minimum of 75% of compulsory classes with attendance control) A) Completion of a written test in class at the end of the course (2 h.) Consisting of a text comment (commentaire composé) to choose between two extracts of texts included in the program. Any duly cited support material may be used (40% of the final grade). B) Two oral tests of about 15 minutes of duration on two readings of entire books included in the program. Any duly cited support material may be used. One will take place in the middle of the course and another at the end (30% of the final grade each). Note: An author who has already worked in the oral presentations cannot be chosen in the final written test. 2. Evaluation in first call (students who have not attended the minimum number of classes required or who so decide) and Evaluation in second call (regardless of class attendance). 1) Completion of a written test on the official examination date (3 h.) Consisting of a text comment (commentaire composé) to choose between two extracts of texts included in the program. Any duly cited support material may be used (50% of the final grade). 2) During the week of the official exam date there will be two oral tests (about 15 minutes long each) on two readings of entire books included in the program. Any duly cited support material may be used (25% of the final grade each). Note: An author who has already worked in the oral presentations cannot be chosen in the final written test. Evaluation



criteria Regarding the linguistic correction of the tests, both written and oral, students must demonstrate a command of the French language coinciding at least with the grammatical contents of the subject of French Language 4 (level B2 of the European Framework of Reference). Excessive grammatical and expression errors in the French language will lead to failure of the subject.

1. Contents

The teaching methodology is maintained but with synchronous videoconferencing through Blackboard Collaborate for students who do not attend in person, depending on the distribution of the group or for duly justified reasons.

4. Assessment

Continuous evaluation (only for First Call):



Attendance control (minimum of 75% of the classes) can be both in person and remotely through the connection through Blackboard Collaborate, depending on the group distribution or for duly justified reasons.

For the written test of “commentaire composé”, it will be done remotely through a connection to Blackboard Collobarate. The texts will be posted in the Virtual Classroom 10 minutes before the start. After 2 hours (or before), it will be sent as "Homework" through Virtual Classroom. The date of completion will be previously agreed with the students, coinciding with the usual schedule, in the last week of classes.

For the control of readings, the two tests will be done online through a connection to Blackboard Collobarate.

Traditional evaluation (First or Second Call):

In-person or remote attendance will not be taken into account.

The official examination session date is maintained (06/07/2021 for the first examination session and 06/29/2021 for the second examination session).

For the written test of “commentaire composé”, it will be done remotely through a connection to Blackboard Collobarate. The texts will be posted in the Virtual Classroom 10 minutes before the start. After 3 hours (or before) it will be sent as “Homework” through the Virtual Classroom.

For the control of readings, the two tests will be done online through the connection to Blackboard Collobarate during the week of the official exam date.
