DESCRIPTION OF CONTENTS

1. Literatura amorosa en prosa del período clásico

Tema 1 - Obras en prosa del período clásico (s. IX a XIV) en torno a la cortesía, el amor y la mujer: humanidades (adab); epístolas literarias, filosóficas y médicas; tratados eróticos medievales; narrativa breve. Se estudiarán: al-Jahiz, al-Wassà, Ibn Dawud, al-Razi, Avicena, Ibn al-Jawzi, Ibn Qayyim, al-Tifasi, al-Tijani, al-Nafzawi, Ibn Kamal Basa. Las mil y una noches.

2. Introducción a la literatura árabe moderna.

Los grandes reformadores de la 'Nahda' y el nacimiento del feminismo árabe. La poesía amorosa de los poetas de la generación de los cincuenta en Iraq dentro del marco de la literatura del 'Desastre'.

Tema 2. El reformismo musulmán y los inicios del feminismo: Huda al-Shaarawi, Qasim Amin y Tahir al-Haddad. Influencias occidentales en el perfil político de la amada: el caso de Nizar Qabbani.

Tema 3. Contexto sociopolítico para una literatura de la 'derrota' a partir de 1948. Lectura del amor en clave política: los iraquíes Badr Shakir al-Sayyab y al-Bayati, los palestinos Mahmud Darwish y Fadwa Tuqan.

3. El conflicto Oriente / Occidente en la literatura árabe.

El conflicto Oriente / Occidente visto por el pensador Edward Said en su obra Orientalismo (1978) y reflejado en la literatura (novela sudanesa), el ensayo sociológico (Fatima Mernissi) y en los textos autobiográficos de las principales escritoras feministas árabes.

Tema 4 - El pensamiento de Edward Said (1935-2003): el imaginario occidental sobre Oriente; del exotismo decimonónico al triunfo del estereotipo y la estigmatización en el siglo XX. Los recientes best-sellers sobre la condición de la mujer musulmana frente a su realidad.

Tema 5 - El ensayo sociológico. Estereotipos orientales acerca del amor y las mujeres en Occidente: la novela egipcia-sudanesa, Rauf Basta y Tayyib Salih. Visión de la mujer occidental desde el feminismo árabe: Dayz al-Amr y Fatima Mernissi.

Tema 6 - Escritoras árabes de nuestros días. Feminismo de signo islamista versus feminismo secular: Amal Lambaret. Textos autobiográficos de Latifa al-Zayyat, Nawal al-Saadawi, y Yumana Haddad.
