SUMMARY

This subject is part of the minor of *French Language and its Literatures*. The subject fulfils the knowledge imparted previously and deepens the competences developed in the subjects of *French Literature (2nd Language: French)* and *French Literature and Culture 1*, which are studied in 2nd and 3rd year, through the study of authors, works and movements representative of medieval and sixteenth French Literature. The subject is taught in the French and it deals with texts in the original language - except those written in old French that are read translated into contemporary French -, which contributes to the reinforcement and development of communicative competences in French.

PREVIOUS KNOWLEDGE

Relationship to other subjects of the same degree

There are no specified enrollment restrictions with other subjects of the curriculum.

Other requirements

- Knowledge and communicative skills in French that allow to read literary texts in their original version, with all the necessary support material, except for the medieval ones that will be read in translations into contemporary French.
- Knowledge and communicative skills in French that allow to understand and express oneself with basic correction, since it will be the language of the teaching and the paper of the subject.

TEACHING METHODOLOGY

- Las profesoras impartirán clases teórico-prácticas yendo de la teoría al texto y del texto a la teoría. Podrán tratar y presentar los contenidos por conceptos o a través del estudio de los géneros literarios de la Edad Media y del siglo XVI franceses.
- Cada tema será introducido por los elementos teóricos necesarios para que el alumnado pueda abordar y estudiar, guiado por las profesoras, el dossier de textos que tendrá a su disposición.
- Se otorgará a la enseñanza por talleres una gran importancia.

EVALUATION

Els estudiants podran ser evaluats per modalitat d'avaluació contínua i final o solament evaluació final.

1. Evaluació contínua i final.

1. Tres exercicis durant el curs. Cada exercici consistirà en la resposta a diverses qüestions relacionades amb els temes i les lectures. 75% de la qualificació final.
2. Un treball sobre un tema relacionat amb una o diverses obres del programa, proposat per l'estudiant i amb l'acord del professor. El treball es lliurà per escrit en la data i de la manera establits pel professor. La defensa oral tindrà lloc durant el període d'exàmens. 25% de qualificació final.

2. Evaluació final

1. Exercici consistent en la resposta a diverses qüestions relacionades amb tots els temes del programa i les lectures. Es realitzarà en la data oficial de l'examen final. 75% de la qualificació final.
2. Un treball sobre un tema relacionat amb una o diverses obres del programa, proposat per l'estudiant i amb l'acord del professor de l'assignatura. El treball es lliurà en la data establida pel professor i es defensarà oralment en el període d'exàmens. 25% de qualificació final.

3. Observacions:

1. Els estudiants que no hagen obtingut una nota mitjana igual o major de 5 en els exercicis de



curs o que no hagen realitzat els tres exercicis: realitzaran obligatòriament l'exercici de de l'avaluació final.

2. La nota obtinguda en l'exercici d'avaluació final substituirà la nota mitjana dels tres exercicis de curs.

3. Solament es procedirà a calcular la nota mitjana final quan s'haja obtingut almenys un 5 en la nota mitjana dels exercicis de curs o en l'exercici de l'examen final i en el treball presentat i defensat oralment.

4. Els treballs lliurats fora del termini i la modalitat establits no seran admesos ni avaluats.

4. Criteris d'avaluació:

1. En tots els exercicis es valorarà l'assimilació dels continguts del curs i la pertinència de la seu exposició en relació amb el tema, autor o obra objecte de l'exercici. També seran objecte de valoració la claredat, ordre i coherència de l'exposició, així com les idees i reflexions personals de l'estudiant. El tractament de la bibliografia serà també objecte de valoració en el treball presentat.

2. El plagi implicarà automàticament el suspens de l'assignatura.

3. Tots els exercicis es realitzaran obligatòriament en llengua francesa. Es valorarà en ells la correcció gramatical i ortogràfica, en el nivell requerit en el curs de l'estudiant.

5. 2^a convocatòria:

1. Es realitzarà seguint el model de l'avaluació final. Els exercicis d'avaluació contínua no seran recuperables. L'exercici final i el treball de curs són recuperables.
