SUMMARY

The subject "Literature and culture of Italian language", is taught in the first two courses and aims to introduce students in Italian literature for the understanding and assimilation of works, authors and aesthetic-literary movements, as well as in its historical-cultural context. In particular, in this subject, three centuries of Italian literature are studied, which were fundamental centuries for the conception and contemporary culture, because in these centuries a mentality and an aesthetic that greatly influences our culture develops. It aims to provide students with knowledge and skills in the subject and transversal, bring students to the authors, works and aesthetic taste of each of the centuries studied and provide them with adequate knowledge of Italian literature of the seventeenth century, XVIII and XIX. The level of Italian language in which the classes will be taught corresponds to an A2 +

TEACHING METHODOLOGY

The teaching methodology seeks above all the autonomy of the student and his active participation in the classes and in the learning. For this reason, techniques and resources are promoted that are oriented towards practice, research and investigation, as well as to stimulate the motivation and interest of the student in Italian literature and its context. The methodology, therefore, is based on the constructivist approach to learning, that is, on the construction of new knowledge through the re-elaboration and modification of the student's previous knowledge. In this way, a significant learning is fostered that favours critical reflection at an individual level, but also at a collective level through the critical commentary of works and the sharing of learning elements.

Different methodologies will be used to organise the knowledge and work of both the teacher and the students: master class, seminars, inverted class, participative activities (online questionnaires, play methodologies, participation in the forum, exhibitions), collaborative works, use of the virtual classroom as a repository of material used for the classes and as a vehicle for communication between the students and between the teacher and the students, as well as different technological resources suitable in each case and with a specific purpose. A fundamental and essential part will be the reading of obligatory texts and some complementary texts, so that the students come closer to the literary fact and, in particular, to the Italian literature of the centuries studied. Theoretical and practical lessons will complement each other and from the two types of teaching the student must acquire the compulsory knowledge set out in the syllabus. The work in the Virtual Classroom will be fundamental to complement and deepen the learning process. Complementary cultural activities that may arise during the course will also be used. In addition, learning will be encouraged in order to carry out work of scientific and academic quality and plagiarism will be penalised. Plagiarism will be totally prohibited and penalised in all work of any kind and the grade, if plagiarism is verified, will be equal to 0.

Students must be very clear that, in this subject, they cannot limit themselves to taking notes in class and maintain a passive, only receptive, aptitude. This is not the objective pursued, nor is it in accordance with the above-mentioned teaching methodology, which is of an active nature for the students. All the activities of the subject must be carried out to obtain a good result, but it is essential that the students work with maturity and responsibility. In class they are expected to be participative, to expose their doubts and their progress, to express their opinions freely, but always with criterion and critical point of view. Students are also expected to fulfill their obligations: readings, activities, comments, etc. All this will result in the acquisition and understanding of the contents of the subject so that the proposed objectives can be fulfilled: the learning of the contents.

EVALUATION

The evaluation includes several sections that must be passed, each one of them, at least 50% in order to obtain the average mark of the total of the course. One of the sections is the final exam and the rest is made up of different activities that must be completed throughout the course. These activities correspond to the continuous assessment and are made up of activities that students are REQUIRED to do.

Each of the sections described above, and those into which they are subdivided, are compulsory for all students on the course. In the event that any student fails to present or complete any of the sections, the final mark will be No Show and the average mark will not be calculated until it is completed in the second sitting. In any case, all those compulsory activities carried out and passed will maintain the grade for the second call in the absence of completing them. In order to pass the course as a whole, it is necessary to have passed each and every one of the parts indicated above with a minimum of 50% in each of them, in addition, it is very important to attend the classes to be aware of the contents taught, the activities carried out by the students and all the new developments that are commented on. The written exam will compile all the topics seen in class and may consist of a multiple-choice part and a second part with questions to be developed that relate the theoretical issues with each other or the theoretical issues with the readings done, both in classes and compulsory readings, other types of questions can also be put.

The portfolio will be carried out collaboratively in groups of 4 people for a project to be presented at the end of the course. The aim is to compile and present everything that has been seen and worked on during the course. The characteristics of this work will be explained by the teacher on the first day of class. We remind you that students must be very clear that they cannot just take notes in class and have a passive attitude and limit themselves to a final written exam. This is not the way this course works and that is not the aim of the course. That is why we will take into account the participative attitude of the students, the interest shown in the class sessions and in the exercises, the completion of the tasks set, the reading of all the compulsory works and also of the recommended ones, etc. This is a literature subject and it is therefore essential to be familiar with the texts and to read each one critically, which will be verified in the reading control.

Those students who for very justified reasons cannot attend classes are obliged to inform the teacher of this fact at the beginning of the course or when the situation that prevents their presence in the classroom arises. The teacher will agree a work and follow-up plan with the student so that he/she can continue with the subject, being sure that all the compulsory activities and exercises of the subject are carried out and that the learning process is successful. It is therefore necessary to maintain continuous contact with the teacher of the subject. Failure to attend classes, even if duly justified, does not exempt students from completing each and every one of the assignments and activities carried out in the classes, as without their completion the final mark cannot be obtained. HYBRID MODE OF TEACHING

1. Contents

The contents initially foreseen and included in the Teaching Guide are maintained.

2. Workload and time planning of teaching

The themes that appear in the Teaching Guide are maintained, as well as all the activities and hours of dedication.

The different activities foreseen in the Teaching Guide have been maintained, adding up to the 150 hours of activities foreseen, and no changes have been introduced, maintaining the volume of work foreseen. We also respect those activities designed to be carried out in the classroom and those designed to be carried out outside the classroom.

The scheduled and official timetables for classes and activities are maintained.

3. Teaching methodology

The teaching methodology proposed is that of the inverted class, because it is used both in the case of hybrid teaching and in the case of non-attendance teaching. To be able to carry it out, a series of methodologies and tools are proposed that will serve as the basis for carrying out the teaching, whatever the health reality may be:

-Publication of materials in the virtual classroom

-Proposal of different activities through virtual classroom

-Synchronous video conference by BBC

-Voiceover slides

-Debates in the subject's forums through the Virtual Classroom.

-Project development, teamwork and ABP

-Tutorials for videoconferencing at BBC

-Training tests: completion of Virtual Classroom and other online questionnaires and completion of AV tasks

-Seminars

If it is not possible to take the exam in the classroom, it will be replaced by a summative test that will consist of a test to be taken with the application of the AV questionnaire and some questions to be developed that will also be answered in the Virtual Classroom (questionnaire or tasks). This test will have a weight of 40%.

The continuous evaluation modifies its percentage from the Teaching Guide to 60%. The continuous assessment will take into account the work done by the students during the course, both in school hours and in asynchronous hours.

1. Contents

The contents initially foreseen and included in the Teaching Guide are maintained.

2. Workload and time planning of teaching

The themes that appear in the Teaching Guide are maintained, as well as all the activities and hours of dedication.

The different activities foreseen in the Teaching Guide have been maintained, adding up to the 150 hours of activities foreseen, and no changes have been introduced, maintaining the volume of work foreseen. We also respect those activities designed to be carried out in the classroom and those designed to be carried out outside the classroom.



The scheduled and official timetables for classes and activities are maintained.

3. Teaching methodology

The teaching methodology proposed is that of the inverted class, because it is used both in the case of hybrid teaching and in the case of non-attendance teaching. This test will be worth 30% of the final grade.

The continuous evaluation changes its percentage with respect to the Teaching Guide, and it becomes worth 70%. In the continuous evaluation, the work done by the students during the course will be taken into account, both in school time and in asynchronous time.
