SUMMARY

- 1. *Minor* Subject in "Portuguese Language and its Literatures" (6 ECTS credits, 2nd year, 2nd semester).
- 2. This subject has a double aspect: the historical-cultural (where the fundamental elements of Portuguese culture are addressed from the historical events that have shaped it) and the literary one with the study of some of the movements, authors and works highlights of Portuguese literature of the 19th and 20th centuries.
- 3. The course is taught in Portuguese and deals essentially with texts in the original language.

TEACHING METHODOLOGY

The face-to-face teaching consists of four weekly sessions, three of theory and one of oral and written practice that will

complement and reinforce the theoretical classes.

Theoretical classes: On each one of the subjects of the program, following the development specified for each one of them

in the agenda. The teacher will expose the essential contents and explain the way in which they should be approached

by the student. Reading, comprehension and analysis exercises will be carried out.

Practical classes: Reading, explanation, commentary and analysis of historical and literary texts referring to the periods,

movements and authors studied, thus contributing to the assimilation of the aforementioned skills.

Other activities:



Tutorials to resolve doubts that may arise both in theoretical and practical classes, as well as to guide the completion of

work or activities related to the contents of the course.

EVALUATION

The evaluation will consist of two different parts (1st and 2nd call):

- 1. Individual written exam: 80%
- 2. Attendance, class participation and personal work: 20%

The note obtained in part 2 will be valid for both calls.

The written exam will consist of two parts:

- 1) Questions for development and critical reflection on the topics, works and authors explained in class.
- 2) Reading control: questions about compulsory reading books.

Evaluation criteria:

Theory: Knowledge of the main historical events, cultural concepts and movements and authors and works of Portuguese

literature of the 19th and 20th centuries.

Practices: - Ability to read, interpret and analyze works of literature studied in their original language, as communication

skills allow.

- Ability to develop in writing a critical and synthetic reflection on aspects of history, culture and literature studied.
- Reinforcement of communication skills in the Portuguese language.

IMPORTANT NOTE: Students can answer the written exam in Portuguese, Valencian or Spanish. However, students who

answer in Portuguese, as long as their grade is higher than 5, are eligible for a bonus of 0.5 points.
