#### 1. Project

This evaluation will be done with a constructive spirit and inadequate or pejorative language will not be admisable. The maximum length will be 400 words.

# **TEACHING METHODOLOGY**

Attendance at supervisory meetings with the academic tutor (supervisor). In this meetings, the teacher-tutor will guide the student in the realization of the final project (TFG), the supervisor will provide specific bibliography to facilitate the documentation work of the student and will discuss with the student the results and conclusions obtained.

## **EVALUATION**

The Degree's final project (TFG) can be assessed once the student has passed 230 credits of his Degree in ADE.

Once the TFG has been submitted, the supervisor (tutor) will evaluate it in a maximum period of 15 days. The maximum grade the supervisor can grant is "Excellent". To achieve that grade with Honors the student needs to apply to the TFG Committee along with a favourable report of the supervisor, for a public presentation of the TFG in front of an Evaluation Committee.

In the evaluation of the TFG the following aspects will be considered:

- 1. Planning and execution. Timeline, contnet and planning. Up to 20%.
- 2. Formal aspects. Structure, layout, interesting topic. Up to 20%
- 3. Acquired skills. Up to 30%
- 4. Quality signs. Quality, style, methodology. Up to 30%
