The Final Degree Project consists of the student developing in an independent manner a project under the supervision of a tutor, whose realization has the purpose of encouraging the student to integrate the training contents received during their studies and ensure the acquisition of the skills associated with the degree.

The Final Degree Project (TFG) may be of an experimental or bibliographical nature and must address aspects of the Pharmacy degree and the Human Nutrition and Dietetics degree.



The Final Degree Project must be prepared individually by each student (the ownership of the intellectual property rights of the final degree projects correspond to the student who has carried it out and to the tutor, in co-authorship, according to the provisions of the intellectual property law of 1996 with modifications of 2003, in its articles 7 and 8)

### TEACHING METHODOLOGY

The Final Degree Project must be prepared individually by each student.

The student will be receive individual tuition through which the tutor / tutors will guide him/her in the selection and approach of the topic of work, handling of the bibliography, the most useful working methods for the realization of the project and will clarify the doubts that the student poses and will monitor their activity.

## **EVALUATION**

The Final Project for each student will consist of at least: cover (with the title, student's name, name of the tutor, presentation date), summary in English (maximum 300 words), index, introduction and background of the subject, objectives, implementation methodology, results, discussion, conclusions and literature. It will have a minimum extension of 30 numbered pages, written in Times New Roman or similar font, of 12 points, line spacing 1.5, in Din-A4 sheets of 2.5 cm of margins on all 4 sides. The copy must be bound when handed in (not stapled) on the long side. It can be written in any of the official languages of the University or in English. In the latter case, with a summary in Castilian or Valencian.

The student must submit three printed copies of the final report and a digital copy correctly identified to the Secretariat. The corresponding title until will not be issues until the integrity of the digital copy has been verified.

The Final Degree Project will be evaluated by a commission appointed for this purpose by the Final Degree Project Commission for each academic year. The defence of the Final Degree Project will be carried out by each student and will be public. The student will have a maximum of 15 minutes to present their work and the commission will discuss the work with him / her for a maximum of approximately 15 minutes.

The grade will be the result of the tutor's report (30%) and the Commission's evaluation (70%).

The evaluation will take into consideration: scientific quality; expository clarity, both written and oral, and the ability to debate and defend his/her work.



The rules for the preparation of the report, the evaluation criteria of the commission and the documents for the evaluation of the tutor, authorization and deadlines can be consulted on the Double Degree Pharmacy- Human Nutrition and Dietetics webpage of the Final Degree Project section.
