#### 2. The Middle Age

The time of the monasteries. Romanesque architecture. Feudalism and military architecture. Landscape and city in Al-Andalus. The resurgence of the urban world. The medieval town. Gothic architecture. The perception of rural and urban landscape in the painting of the Trecento and Quattrocento.

#### 3. The Modern Age

The Renaissance and architecture. The development of cities, between utopia i reality. Painting in Italy. The birth of landscape as an independent genre in the Nordic painting. The Baroque city. The rise of the garden. The French Baroque garden. The English garden. The landscape in Baroque painting. The return to classicism.

#### 4. The Contemporary world

The Industrial Revolution. The urban reforms. The extensions. Alternatives to the problems of the industrial city: The Arturo Soria Ciudad Lineal and the Garden City of Ebenezer Howard. Architecture: historicism, modernism and modernism. The planning of Le Corbusier. The rural and urban industrial landscape. The perception of landscape in painting.

# **TEACHING METHODOLOGY**

The development of the course is divided into the following points:

a) Three hours per week of classroom: theoretical and practical lessons are taught by the teacher, through visual means, which outlines the essential aspects of the subject, systematizing the literature. In order to continue these classes will require mandatory reading and preparation of materials, manuals and texts, previously indicated. This reading and preparation is required and can be controlled. The practical component will be in these classes, may be the commentary and analysis of texts or images related to the subject.

b) Attendance at seminars, guided tours and other activities. Within this section you can include mandatory attendance of the student in any activity organized by the teacher. These activities will be determined by the number of students in the group.

c) Attendance at tutorials. Students may attend the office hours to students that the teacher has established, to consult on any

topic or aspect of the subject and the teacher can arrange to carry out scheduled tutoring when he sees fit.

### 2. Workload and time schedule

The activities and their hours of dedication in ECTS credits marked in the original course guide will be kept. If the classrooms capacity according to the sanitary norms allows it, the theoretical and practical class attendance will be 100% (if the capacity couldn't be guaranteed, the class attendance would be reduced). Supplementary activities (weekly hour O: total 15 h.) may require attendance (field trips, seminars) or could be online, and will be specified at the beginning of the term in the Annex to the Course Guide, like the rest of the teaching planning.

#### 3. Teaching Methodology

Theory and practice classes that may be complemented with different types of materials and activities in the Virtual classroom.

Tutorials will be done online (through the UV videoconference or by email) or face-to-face by prior appointment with the teacher.
