### TEACHING METHODOLOGY

Theoretical classes, master class with direct participation of the students. Study and commentary on materials specific to the subject such as DO Regulations, examples with identifying labels, etc. Incorporation into the Virtual Classroom of teaching materials, legal texts, and notes for monitoring classes. Occasionally, students can be asked to prepare certain materials before class for their subsequent participatory and critical comment during the sessions or to prepare written comments / analyzes on the subject.

### EVALUATION

Middle of the subject (Commercial law): Written test (exam) based on learning outcomes (70%). Continuous evaluation of the student's work, including active attendance at sessions, participation, elaboration of comments or assumptions that may be made (30%). It is necessary to pass (5) the written test so that it is average with the continuous evaluation. The other half of the subject (Administrative Law): presentation of practical work indicated by the teacher 50%.
