SUMMARY

Diachronic study of the structure and dynamics of modern society, global and local, in its multiple dimensions, understood as the context and system in which the audiovisual communication subsystem is framed and developed.

This subject aims at introducing into the knowledge of the main concepts and problems of contemporary history, from 1945 onwards. Attention should be paid to the socioeconomic as well as political and cultural developments, which shaped the world we are living in. The relationships will be stressed between such historical developments with our present, in order to spark the discussion about the problems of our geopolitical stage and its historical roots.

TEACHING METHODOLOGY

- Master class: explanations on the various topics by the teacher.
- Theoretical-practical problem solving: practical class: home viewing and commentary in class of historical films related to the topic, to comment and deepen on it.

- Debates and seminars: student participation in the commentary of readings and projections.

EVALUATION

The general grading system will follow the Regulation of evaluation and grading of the Universitat de València for bachelor's and master's degrees, approved by the Consell de Govern on May 30, 2017 (ACGUV 108/2017).

- 1.- **Final exam** (60%). It will deal with the contents of the program. The following aspects will be evaluated:
- Level of knowledge in accordance with the objectives of the course.
- Correct written expression, both from the expository and formal point of view (clear writing and correct spelling), as well as terminology.
- Ability to relate and reasoning.

The grade obtained in this section will represent 60% of the final grade of the course. The mark must be equal or higher than 4.5 (out of 10) so that the results of the remaining evaluation criteria can be added to



it.

- 2.- Group work (30%).
- 3. Active, reasoned and regular **participation in the classroom** (10%).

The second call has the same requirements and percentages as the first one. If the grades obtained throughout the course in the assignments, reading controls and other evaluation criteria were satisfactory, these will be taken into account for the grade of the second call.

In addition, at the beginning of the course, the specific detailed program and the specific indications on the dynamics in each group by the responsible teacher may be presented as an annex.

Problems with spelling, syntax and/or written expression will be scored negatively and may result in failure of the test.

In case of plagiarism in a student's evaluation work, this may be evaluated with a numerical grade of zero, regardless of the disciplinary procedure that may be initiated and, if applicable, the appropriate sanction in accordance with current legislation.

Intellectual honesty is vital to an academic community and for the fair evaluation of the student's work. All work submitted in this course must be originally authored by every student. No student shall engage in unauthorized collaboration or make use of ChatGPT or other AI composition software.
